ORDINANCE NO. 6

AN ORDINANCE to compel all owners of lots or parts of lots in the Town of Mardela Springs to clean weeds and grass from the same or cause the weeds and grass to be cleaned therefrom, and provide penalties for the violations of its provisions.

SECTION I. BE IT ENACTED AND ORDAINED by The Commissione of Mardela Springs, that every owner of any lot or part of any in the Town of Mardela Springs shall keep the same clean by cu at all times therefrom all weeds and grass more than six (6) i in height and removing therefrom all cut grass and weeds.

SECTION II. AND BE IT FURTHER ENACTED AND ORDAINED by Th Commissioners of Mardela Springs that any person violating the provisions of the aforegoing Section of this Ordinance shall deemed guilty of a misdemeanor, and upon conviction thereof be the Judge of the Peoples Court for Wicomico County, shall be f not exceeding the sum of Ten Dollars (\$10.00) and stand commit to jail until the said fine and costs are paid.

SECTION III. AND BE IT FURTHER ENACTED AND ORDAINED by T Commissioners of Mardela Springs that permitting existence of weeds or grass more than six (6) inches in height upon any lot part of a lot in the Town of Mardela Springs is hereby declare be a nuisance and the Commissioners of Mardela Springs, after notice to the owner or owners of any lot or part of a lot on w such a nuisance is maintained, to be served through its agents servants upon the occupant of the premises, or by posting upon property, shall have the right and power to have its agents or servants or employees go upon such property and abate such nui by cutting, removing and cleaning therefrom such grass or weed The cost of such cutting, removing or cleaning shall be a lien against the property and the owner or owners thereof shall be liable therefor in the same manner as said owner or owners are Town taxes or other debts due the Commissioners of Mardela Spr SECTION IV. AND BE IT FURTHER ENACTED AND ORDAINED by Th



ORDINANCE NO.

AN ORDINANCE TO PROVIDE FOR A UNIFORM SETBACK FOR ALL UTILITY POLES ALONG AND UPON ALL PUBLIC STREETS AND/OR HIGHWAYS IN THE TOWN OF MARDELA SPRINGS, MARYLAND.

SECTION I. BE IT ENACTED AND ORDAINED by the Commissioners of Mardela Springs, Maryland, that from and after the date hereof all utility poles situate, located or placed in and along all streets, boulevards or highways located within the corporate limits of said Town shall be placed at a distance of not less than six (6) inches and not more than eight (8) inches from the sides of the curb along said streets, boulevards or highways to the face of the utility pole.

SECTION II. AND BE IT FURTHER ENACTED AND ORDAINED by the Commissioners of Mardela Springs, Maryland, that any individual, corporation, partnership or association, their servants, agents or employees, who shall violate the provision of this Ordinance shall, upon the conviction thereof before the Trial Magistrate or any Judge of Wicomico County, Maryland, be fined not less than Five Dollars (\$5.00) nor more than Ten Dollars (\$10.00) for each and every offense.

AND BE IT FURTHER ENACTED AND ORDAINED by the SECTION III. Commissioners of Mardela Springs, Maryland, that this Ordinance shall take effect ten (10) days from and after the date of its final passage.
