A RESOLUTION AUTHORIZING THE CREATION OF A NEW SINKING FUND FOR PUBLIC WORKS RELATED ITEMS

WHEREAS, the Public Works department has expense accounts designated specifically for their department for operation expenses year-to-year;

WHEREAS, the Public Works department has not always expensed the budgeted amount allocated to those expense accounts year-to-year leaving a surplus in those designated expense accounts;

WHEREAS, it is the Village of North Freedom's intention to help aid in future expenses/purchases for the Public Works Department by creating a Sinking Fund designated for those functions,

NOW THEREFORE, that based on the 2024 preliminary year-to-date numbers (prior to audit completion), there is a surplus of \$1,094.60 in the Equipment Repairs/Maintenance expense account and a surplus of \$3,265.25 in the PW Supplies & Improvements expense account, see figure A below:
