### **DATES, TIMES, & LOCATIONS:**

- Arts/Crafts/Flea Market – 6/28/25 – 10:00 AM to 4:00 PM at/on S Oak Street, North Freedom, WI
- Farmers Market – 6/29/25 – 11:00 AM to 3:00 PM at/on S Oak Street, North Freedom, WI

### **FEES:**

\$10.00 for a 10’ X 10’ space – No refunds or rain date

*Payment must be included with this packet in order for your spot to be reserved. If you need to pay online, please contact the Village Office and inquire about available options. Payments can be made payable to: Village of North Freedom. Please include in the Memo line whether it is for the Arts/Crafts/Flea Market or Farmers Market (or for both days). Mailed payments can be sent to PO Box 300, North Freedom, WI 53951.*

### **MARKET RULES**

- The Village of North Freedom holds no responsibility, included but not limited to, for food/items sold, accidents, weather, theft, or damages of any kind associated with the sale of items at the subject market event(s).
- There is no electricity at/in the market space.
- Vendors are responsible for providing their own tables, tent, chairs, supplies, change, etc. If using a tent, tents should be weighted when necessary
- For Farmers Market vendors: all Farmers Market vendors must adhere to ALL State (DATCP) and Sauk County regulations associated with being an official Farmers Market vendor, including any weights/measures, labeling, licenses & laws.

- Spaces are assigned based on individual needs and arrival time.
- Vendors are responsible for Sales Permits & paying any applicable taxes.
- Vendors must return the space to the condition it was prior to use at the end of each market.
- No smoking during market hours in the market area.
- There will be barricades that you can drive through to get into the space off of Willow Street – E Walnut will be closed off to the public – to set up but after set up, you will need to park your vehicle elsewhere. The Village Green-Space, just down from the market space will be available for parking.
