# Minocqua Police Activity Report August, 2024

### Incidents:

During the month of August 2024, the Minocqua Police Department handled 695 incidents with an additional 392 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 695 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
