## Minocqua Police Activity Report February, 2017

#### Incidents:

During the month of February, 2017, the Minocqua Police Department handled 513 incidents with an additional 371 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 513 incidents also include calls self-initiated by officers of the Department. This compares with 388 calls for service during February 2016; 267 calls for service during February, 2015; 291 calls for service during February, 2014; 282 calls for service during February 2013; 293 calls for service during February 2012; 302 calls for service during February, 2011; 389 calls for service during February 2010; and 446 calls for service during February 2009.
