Minocqua Police Activity Report January, 2019

Incidents:

During the month of January, 2019, the Minocqua Police Department handled 439 incidents with an additional 360 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 439 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
