Minocqua Police Activity Report May, 2023

Incidents:

During the month of May, 2023, the Minocqua Police Department handled 663 incidents with an additional 417 calls for service from the public which involved dispatching Woodruff Police Department, fire and EMS. The 663 incidents also include calls self-initiated by officers of the Department. A breakdown of those calls in comparison to past years is as follows:
