3.03	Regulate the Placement of Driveways	Forfeiture: Deposit	Not less than \$100, but not more than \$250 plus costs. \$263.50
3.07	Depositing Snow and/or Ice	Forfeiture:	Not less than \$25 nor more than \$50 together with the costs of prosecution and upon conviction for the second and subsequent offenses forfeit a sum not less than \$50 nor more than \$75 together with the costs of prosecution.
		Deposit:	\$169 first offense, \$200.50 second offense
3.09	Weight Limit	Forfeiture:	\$300 payable to the Town of Cassian plus all costs associated with the prosecution of the offense.
		Deposit:	\$515.50
3.10	State Traffic Laws	Forfeiture:	The statutory provisions described in defining offenses against the peace and good order of the state are adopted by reference to define offenses against the peace and good order of the Town and the forfeitures shall be as provided by the State of Wisconsin Revised Uniform State Traffic Deposit Schedule imposed as provided in Section 345.20 to 345.53 Wis. Stats.
		Deposit:	Per Revised Uniform Traffic Deposit Schedule.

3.11	Road Naming	Forfeiture:	Not less than \$25 nor more than \$100 plus costs.
		Deposit:	\$169
4.01	Boating	Forfeiture:	Not more than \$50 for the first offense and not more than \$100 upon conviction of the same offense at a subsequent time within one year.
		Deposit:	\$200.50
2012-008	Dogs	Forfeiture:	Not less than \$25 for the first offense and not less than \$100 for the second offense in the same year.
		Deposit:	\$169
2012-009	Cats	Forfeiture:	Not less than \$25 for the first offense and not less than \$100 for the second offense in the same year.
		Deposit:	\$169
2008-01	Land Divisions	Forfeiture:	First offense, forfeit not less than \$100 per day nor more than \$500 per day, together with the cost of prosecution. Second offense, within one (1) year shall upon conviction thereof, forfeit not less than \$500 per day nor more than \$1,000 per day for each such offense, together with the cost of prosecution. (See Ordinance for balance of penalty.)
		Deposit:	\$263.50
2009-001	Town Road Protection	Forfeiture:	Shall be \$300 payable to the Town of Cassian plus the cost of restitution for damage to Town Road or Right-of-Way and costs of towing or expenses to clear road.
		Deposit:	\$515.50

2009-003A	Parking on Town Roads	Forfeiture:	Shall be \$25 for first offense and \$100 for second offense within the same year, plus costs of towing, applicable surcharges, assessments, and cost for each violation. Each day a violation exists or continues shall be considered a separate offense under this Ordinance. In addition, the Town Board may seek injunctive relief from a court of record to enjoin further violations.

2009-004	Uniform Dwelling Code	Forfeiture:	Shall be not less than \$50 nor more than \$500 for each day of noncompliance.
		Deposit:	\$200.50
2011-001	Amended Ordinance to Regulate Parking of Vehicles	Forfeiture:	\$250 per day. Each day is a separate violation and a separate offense under the Ordinance.
		Deposit:	\$154.50, Range \$25-\$500
2012-005	Destruction of Obsolete Records	Forfeiture:	\$250
		Deposit:	\$452.50, Range \$250-\$1,000
2012-007	Ordinance Relating to the Confidentiality of Income and Expenses	Forfeiture:	\$100
		Deposit:	\$263.50, Range \$100-\$300
2013-002	Town Board of Cassian Declares Itself the Governing Body of the Union Grove Cemetery, a municipal cemetery	Forfeiture:	\$10 per day for each violation
		Deposit:	\$150.10
