AMENDED ORDINANCE TO REGULATE PARKING OF VEHICLES

2011-001

STATE OF WISCONSIN TOWN OF CASSIAN ONEIDA COUNTY

The Town Board of the Town of Cassian, Oneida County, Wisconsin, by this Resolution, adopted by a majority of the Town Board on a roll call vote with a quorum present and voting and proper notice having been given resolves and orders as follows:

- A. The Town Board has specific authority to adopt this ordinance under Section 349.13, Wis. Stats.
- B. The parking of vehicles on the following town highways in the Town of Cassian is subject to the following restrictions and limitations:
 - (1) No vehicle may park on cul-de-sacs at the end of the following Town Roads:

Deershiner Lane West Jimmy Lane Birch Lake Road Jackson Heights Road Seed Lake Road South Lona Lake Wild Rose Road Road Hemlock Lane Tall Pines Lane Bear Track Lane Boden Road Elsner Road Forest Road North Alva Road

(2) No vehicle may park on boat landing turnarounds at the end of the following Town Roads:

Cranberry Road Little Horsehead Lake Road

Bass Lane Little Bearskin Road

Spruce Lake Timber Lake

Hodag Boat Landing Goodyear Lake Public Landing

(3) No vehicle may park on the following described Fire Department water loading areas:

Little Bearskin Creek Road at Creek

Lakewood Road and Bearskin Creek (about 3800 Lakewood Road) Lakewood Road and Bearskin Creek (about 4770 Lakewood Road) South Shore Road and Bearskin Creek (about 9243 South Store Road)

- Church Road and Bearskin Creek (at the intersection with Harshaw Road) Harshaw Road and Bearskin Creek (about 870 Harshaw Road)
- (4) The Town Chairperson, or his or her designee, shall place appropriate traffic signs on the above-named highways on or before the effective date of this ordinance.
- C. There is hereby enacted a winter parking ban. No vehicle may park on any Cassian Town Roads from November 1 through April 15 each winter. This winter parking ban shall be in effect for the blacktop portion of any blacktop Town Road and the traveled portion of any gravel Town Road. Parking is expressly permitted on the shoulders of gravel and blacktopped roads provided no part of the parked vehicle encroaches upon the traveled roadway or the blacktop roadway as described above.
- D. No person may park any vehicle on the above-listed Town Highways in violation of the foregoing parking restrictions and limitations. Any violation of this Ordinance shall subject the violator to forfeiture as noted on the current Town of Cassian Forfeiture and Deposit Schedule.
