AMEND AND ADOPTING THE GENERAL ORDINANCES DATED OCTOBER 16, 1991

9.01 Open Records Resolution




NOW, THEREFORE, the Town Board of the Town of Cassian does ordain as follows:


Section 1. That the code of ordinances for the Town of Cassian as amended shall be hereby is adopted as the general ordinances in and for the Town of Cassian.

Section 2. This ordinances shall take effect the day after passage and publication as provided by law.


