ROSS TOWNSHIP FIRE DEPARTMENT

A Legacy of Service and Growth


The Ross Township Fire Department is committed to providing the highest level of emergency services to our community. Today, the department responds to nearly 2,000 calls annually, conducts over 200 life safety inspections, provides nearly 1,000 hours of community fire prevention education, transports around 800 residents to hospitals, and has saved the community nearly \$2 million in **property loss** due to fire. The department provides Advanced Life Support (ALS) services, ensuring residents receive the highest level of pre-hospital care with paramedics trained in advanced airway management, cardiac monitoring, and life-saving interventions. Additionally, the department is equipped to handle fire suppression, technical rescue operations, hazardous materials response, and disaster preparedness efforts to meet the evolving needs of the community.

Since its founding in 1917, the Ross Township Fire Department has continually evolved to provide the best possible service. Over the past 20 years,

the community has grown by approximately 1,200 homes, resulting in a nearly 4,000-person

increase in population, nearly doubling the community's size. This growth has significantly increased the demand for emergency services. For many years, the department relied on a dedicated group of volunteers to answer emergency calls.

However, as work and family commitments increased, it became more difficult for volunteers to balance their personal lives with the demands of emergency response. This decline in volunteer availability led the department to introduce part-time professional firefighters to ensure adequate staffing during peak hours.

As time went on, the challenge of retaining part-time personnel grew due to increased competition from other departments offering

higher wages and better benefits for full-time positions. Many part-time professionals moved on to full-time careers elsewhere, making it difficult to maintain a stable workforce. In response, the department made the critical decision to hire full-time personnel to fill these gaps and ensure reliable emergency response for the community.

Despite these challenges, the Ross Township Fire Department remains committed to providing the very best service to the community while maintaining strong fiscal responsibility. The department has operated without any increase to its operating budget for the last 10 years, even as the costs for equipment, services, and—most importantly—our employees have steadily risen. Being fiscally responsible, Ross Township Fire Department has applied for and received almost \$400,000 in grant monies since 2014. Previous levies approved by the voters have been subject to a "roll back"; by law, levies cannot generate more dollars than in the first year of passage resulting in a reduction of the costs to residents each year. As both the population and the number of emergency responses have increased, the Ross Fire Department continues to maintain an outstanding record of fiscal responsibility which has enabled



the department to achieve more with less, without compromising the quality of service.

In November, the department will place a new 6.5 mill levy on the ballot. This proposed levy is necessary to generate sufficient revenue to sustain the department into the future and ensure its continued fiscal stability. If passed, the new levy would **replace** the two existing fire levies, which would **immediately be rescinded.** This change would simplify the department's funding structure and ensure long-term stability with a single, consolidated levy. The net result would be an increase of approximately \$375 annually—or about \$1.03 per day-- for a home valued at \$300,000—an investment in the safety and well-being of the entire community.

The Ross Township Fire Department has planned carefully for the future, balancing the community's needs with financial prudence. This levy represents a critical step forward to ensure the department can continue its mission—to Save Lives, Protect Property, Protect the Environment, Provide the Best Service Possible, and Treat People Nice. As the community grows, the department remains steadfast in its dedication to adapt, improve, and deliver the best possible service to every resident it serves.
