Resolution 2018-01

Adopting the Amended 2017-2027 Brown County Farmland Preservation Plan; Adopted by the Brown County Board of Supervisors, adding parcels.

WHEREAS, Pursuant to Wisconsin Statutes, Chapter 91, Brown County was required to prepare and adopt a Farmland Preservation Plan; and

WHEREAS, the Brown County Board of Supervisors adopted the current 2017-20 Brown County Farmland Preservation Plan (FPP) in 2017, and the FPP was subsequently certified by the WI Department of Agriculture, Trade and Consumer Protection:

and WHEREAS, the Towns of Humboldt, Ledgeview and Wrightstown, and the Village of Hobart, desire to have a total of 17 additional parcels included in the FPP as Farmland Preservation Areas in order to make said parcels eligible to receive the WI Farmland Preservation Income Tax Credit:

and WHEREAS, over the past year, Brown County has coordinated with participating Brown County communities and the WI Department of Agriculture, Trade and Consumer Protection in order to prepare an amended FPP which includes the 17 parcels;

and WHEREAS, it is desired to have the Brown County Board of Supervisors amend the current FPP by adding the parcels to the FPP, and to adopt the amended FPP;

and WHEREAS, all statutory and other regulations have been complied with to date in order to enable the parcels to be added to the FPP, including but not limited to the provision of a Class I Public Notice, the provision of a 30-day review period, and the holding of a Public Hearing on 09-06-2017.

and WHEREAS, that the Brown County Board of Supervisors on December 18, 2017, has amended the current 2017-2027 Brown County Farmland Preservation Plan by adding certain parcels to the current 2017-2027 Brown County Farmland Preservation Plan;

And WHEREAS, the Town Board for the Town of Wrightstown, having held a public hearing and given proper notice to all parties, wishes to adopt the amended Farmland Preservation Plan Map, including 9 parcels from the Town of Wrightstown;

NOW THEREFORE, BE IT RESOLVED that the Town Board for the Town of Wrightstown, Brown County, Wisconsin, does hereby adopt the amended Farmland Preservation Plan Map, including the subsequently mentioned parcels to be eligible for the WI Farmland Preservation Income Tax Credit tax credit; those being Town of Wrightstown Parcels W-54, W-59, W-60, W-61, W-62, W-63, W-65, W-18 and W-21-3
