## Ordinance 2021-01 AN ORDINANCE ENACTING THE REVISED MUNICIPAL CODE OF THE

VILLAGE OF MONTFORT, GRANT AND IOWA COUNTIES, WISCONSIN

WHEREAS, Section 60.0103 of the Wisconsin Statutes authorizes this Board to adopt a code of the general ordinances of the Village by an ordinance referring thereto, and such code may be published in book form and such publication shall be sufficient even though the ordinances contained in the code are not published in accordance with s. 61.50(1); and

WHEREAS, the Village Board deems it to be in the best interests of the Village that its code of ordinances be revised, recodified and reenacted; and

WHEREAS, this Board has caused a revised Municipal Code to be prepared, and a copy of said Code has been on file in the office of the Village Clerk and open to public inspection for at least two weeks before the adoption of this ordinance; and

WHEREAS, notice of said availability of the proposed Code and notice of a public hearing on the proposed Code was posted in three public places in the Village and on the Village's website on May 26, 2021; and

WHEREAS, a public hearing was separately noticed and held on June 16, 2021, with respect to the revisions to Chapter 11 (subdivisions) and Chapter 12 (zoning) of the code;

NOW, THEREFORE, THE VILLAGE BOARD OF THE VILLAGE OF MONTFORT, GRANT AND IOWA COUNTIES, WISCONSIN, DO HEREBY ORDAIN AS FOLLOWS:

**Section I.** The revised Municipal Code of the Village of Montfort is enacted by reference.

**Section II.** Said Municipal Code is published in book form and a copy of it shall be permanently on file and open to public inspection in the Office of the Village Clerk, Montfort, Wisconsin.

**Section III.** The Municipal Code of the Village of Montfort shall take effect upon adoption and publication of this ordinance, as provided by law.
