

Amendments to Ordinance 211-17(3)(4)(5(1a)(1b)(1c))

Town of Freedom – Ordinance 211-17

IT IS HEREBY ORDAINED BY THE TOWN BOARD OF THE TOWN OF FREEDOM, WISCONSIN, SAUK COUNTY:

SECTION 1: PURPOSE:

The purpose of this ordinance is to amend and revise the Town of Freedom Ordinance 211-17 titled "All-Terrain Vehicle (ATV) and Utility-Terrain Vehicle (UTV) Routs On Highways in Town of Freedom"

SECTION 2: PROVISION TO BE AMENDED AND REVISED:

Town of Freedom Ordinance 211-17 (3.1)(4)(51A&1B)

SECTION 3: PROVISION AS AMENDED AND REVISED:

3.1 All roads in the Town of Freedom are designated All-Terrain Vehicle(ATV)/Utility Terrain Vehicle(UTV) Routes.

4 Under the direction of the Town, route signs shall be provided by and shall be marked by the Sauk Ridge Runners ATV Club or their successor with uniform all-terrain vehicle route signs in accordance with Wisconsin Administrative Code § NR 64.12 (7). Signage shall be inspected annually and shall be maintained by the Sauk Ridge Runners ATV Club or their successor. The Town shall be notified immediately in any change in responsibility for maintenance of ATV/UTV Route signs. Sauk Ridge Runners ATV Club will maintain all signs within Township at no cost to the Township

5(1)(a) ATVs and UTVs shall not be operated on an approved route other than between 6:00AM and 10:00PM

5(1)(b) ATV's and UTVs shall be operated on a route at a safe speed not to exceed 45 miles per hour unless a reduced speed is otherwise required by law.

5(1)(c) Removal of (5)(1)(c)

SECTION 4: VALIDITY

Should any section, clause, or provision of the Ordinance be declared by the Courts to be invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

SECTION 5: CONFLICTING PROVISIONS REPEALED:

All Ordinances in conflict with any provisions of this Ordinance are hereby repealed.


SECTION 6: EFFECTIVE DATE:

This amendment shall become effective upon adoption and publication provided by statute.


SECTION 7: PART OF ORDINANCE:
