

## DOG OWNERS

Remember all dogs must be licensed by April 1. Payment postmarked after March 31 will automatically be assessed a \$5.00 late fee. After May 1, fines up to \$100.00 per unlicensed dog may be assessed.

To license a dog, make check payable to Town of Stettin and mail to Town of Stettin Treasurer at 142430 Countryside Dr, Wausau, WI 54401 along with current proof of rabies vaccination and the appropriate fee.

License fees are as follows:

Males/Females ..... \$20.00  
Males/Females (spayed/neutered) ..... \$10.00  
\*Kennel License for up to 12 dogs,  
requires at least 3 acres of property ..... \$50.00  
Puppies (less than 2 months on April 1) 1/2 of adult  
license fee

If you acquire another dog throughout the year, it must be licensed at that time. Also, if you no longer have a pet, please send this information along so that the treasurer may keep her records current.

\*Section 4.05 (7)(a) of the municipal code of the Town of Stettin allows for a maximum of 12 dogs on a parcel of land 3 acres or larger. For a parcel of land less than 3 acres, not more than 3 dogs and 2 cats are allowed.

- \*\* Permits MUST be requested at least 48 hours in advance of burning\*\*
- \*\* Permit holder MUST call Marathon County Sheriff Dept at 715-261-1200 to report planned burning

## STETTIN SNOW SEASON

Plowing snow across the roads from your driveway is not allowed. It freezes solid and can damage our snowplows. If it is necessary to bring our front end loader to move the snow, we will charge you \$100/hour, with a minimum of \$100.

When you are cleaning your driveway, please put the snow on the left side facing your driveway from the road, so our plow does not put it back in your driveway.

The garbage containers should not be placed closer to the road than your mailbox, so the plow driver can clear the road as close as possible to your mailbox.

The Town will not be responsible for damages to mailboxes, caused by snowplowing. Our drivers use the utmost care to avoid damage.

## NOTES FROM THE TREASURER

**TAXPAYERS**, any taxes not yet paid for 2023 must be sent directly to the Marathon County Treasurer- 500 Forest Street, Wausau, WI 54403. The Treasurer cannot accept any tax payments postmarked after January 31 of the year. They will be returned to you after that date as she must make settlement with the County at that time. **All payments after that time must be sent directly to the Marathon County Treasurer**, 500 Forest Street, Wausau, WI 54403 with the appropriate stub.

REMEMBER: You may dispose of up to 60 pounds of construction material and small appliances in your weekly garbage pickup. Building Contractors should not bring material to the Town Garage unless it is from remodeling their own home located in Stettin.

The town will **NOT** accept small items such as vacuum cleaners, water hoses, luggage, toys, clothing, radios, broken window panes and other items which can be placed in your weekly garbage collection. Also **NOT** accepted: air conditioners, microwave ovens, freezers, dehumidifiers, water purifiers, lead based paints, silo baggage, shingles, tires or building materials. The town is **NOT** allowed to accept fluorescent bulbs or hazardous, toxic materials.

Please no dumping after 3:00pm. The town garage is under surveillance. The town **NO LONGER ACCEPTS** electronics: NO TVs, computers, DVD Players, Cell phones or copper wire.

It is illegal to throw out your used oil filters in your trash. The town will accept your used filters, brought in plastic bags and motor oil, (no cooking oil or anti-freeze) The motor oil should be in a labeled 1 gallon container, placed by the oil container drop site at the town hall.

## YARD WASTE DISPOSAL INFORMATION:

Yard Waste Disposal Information: **OPEN FROM APRIL 1 TO NOVEMBER 30. Town residents only, no commercial dumping.** Acceptable items include: Tree branches, leaves and lawn clippings. **NO STUMPS OR LOGS.**

**REMINDER: Garbage is weekly pick up and recycling bi-weekly pickup. Calendar on Town Website. NO DUMPING AT NEW TOWN HALL**



# MAILBOX GUIDELINES

The United States Postal Office requires that the front of the mailbox be between 24 inches and 36 inches off of the edge of the pavement. They require that the bottom of the mailbox be from 42 inches to 46 inches above the edge of the pavement. The Town of Stettin would prefer that the mailbox be placed as far off the pavement edge and as far above the pavement edge as possible while still having the positioning meet the postal service requirements for mail delivery. The Town will not be responsible for mailboxes and posts damaged by plows or flying snow.



## USE CAUTION

The Town of Stettin Garage and Town Hall site have heavy equipment in use for municipal activities. The Stettin insurance provider and the Town Board are concerned about safety and are requesting that children under 16 years should remain in vehicles or wait in the Stettin Town Hall while any business or activity is being conducted on site.
