**TOWN OF MONTROSE
DANE COUNTY, WISCONSIN**

**RESOLUTION TO NAME PREVIOUS PORTION OF
STATE HIGHWAY 69, NOW A TOWNSHIP ROAD**

RECITALS

- A. WHEREAS, a portion of what had been previously State Highway 69, became a township road as a result of the State Highway 69 reroute conducted by the State of Wisconsin in 2023.
- B. WHEREAS, in order to provide an accurate and systematic means of identifying and locating property, assist in the proper delivery of mail, packages, utilities, services, and for emergency vehicles.
- C. This Resolution was noticed and posted in 2 public places, and placed electronically on the Internet site maintained by the Town of Montrose. A copy of the Notice was mailed 30 days prior to the three owners of property that live along the old portion of State Highway 69, to be named. A public hearing was held before the Town of Montrose on June 4, 2024.
- D. WHEREAS, The Town Board of the Town of Montrose by unanimous approval by motion and Resolution on June 4, 2024, adopted by majority vote of the Town Board with a quorum present and voting and proper notice having been given, resolves and declares as follows:
- E. THEREFORE BE IT RESOLVED THAT the portion heretofore referred to as “old 69”. The name Zimbacken Lane is hereby adopted, from this day hence.
- F. BE IT FURTHER RESOLVED, that the Town of Montrose agrees to place and maintain the signs calling attention to this naming.

Official Map Amendment. The Village’s official map shall hereby be amended consistent with this Resolution.

The above Resolution was duly adopted at the meeting of the Town of Montrose on June 24, 2024.
