

Public Hearing Notice for the Town of East Troy

Please note that a Public Hearing to gather educational information and public input regarding wake surfing will be held on this date at the Town of East Troy Town Hall. Public comments will be taken on this subject and reputable subject matter sources will have an opportunity to present information regarding wake surfing on all Town of East Troy lakes.

The Public Hearing will begin with presentations, which may be limited based on the number of presenters. There will also be a time period for questions and answers. If there are any interested presenters, please contact Clerk/Treasurer Buchanan and/or Deputy Clerk/Treasurer Loth on or before October 4, 2025. All presenters will be pre-approved, by the Town board no later than October 8, to balance equal time and ensure as much detailed information as possible is conveyed.

Following the presentations, any individual wishing to speak during the hearing will be required to sign-up at the door to expedite the process. Important, this Public Hearing is for information gathering only! There is no proposed ordinance, there will be no voting, and the Town Board will not be taking any action at the conclusion of the Public Hearing.

AT THE PUBLIC HEARING

At the Town of East Troy, we believe an involved citizenry is the hallmark of a strong community and an effective government.

The public hearing will be live-streamed and recorded for future reference.

Presentation Testimonies

- The length of presentations may be limited based on the number of presenters.
- There will be scheduled time slots, for pre-arranged, formal presentations from reputable sources and subject to Town board approval to balance time and ensure as much detailed information as possible is conveyed.
- Tentatively scheduling a maximum of six testimony presentations to not exceed 15-20 minutes however, time is dependent on the number of approved presentations.
- Conference room equipment will be available for PowerPoint or video presentations. Please contact Jennifer Olson at the Town Hall to coordinate.

Individual Testimonies

- If an individual wants to speak at Public Comments, testimony is limited to four (4) minutes per person.
- Locate the Speaker Sign-Up Sheet: Find the designated table where the official speaking sign-up sheet is located at the door to expedite the process.
- Sign In: Legibly write your name, address, phone number, and the topic you will be discussing.
- Wait for Your Turn: Be patient and stay in or near the hearing room until your name is called. We would like 2 to 3 speakers on deck at all times.
- Names will be called in the order of the sign-up sheet.
- When called, clearly state your name and residential address for the public record.
- Speak directly into the microphone, slowly and clearly.
- Focus on making your points. It's best to prepare written comments to make all your points.
- Your testimony is limited to your own personal knowledge or opinions.
