

How to access your property taxes from almost anywhere!

Please note the tax collection information in the letter at the end of this tutorial.

See steps below. There are screenshots to help if you scroll down past the text. 😊

Keep in mind, less is more! Meaning – do not put the street number and street name in, don't put in the last name and street number. Try to only enter info in one search blank.

1. Go to co.walworth.wi.us
2. Hover over **Services**
3. Select **Real Estate and Personal Property Tax Search** -- If it takes you to a log in page (only two boxes show), simply click on it again and that should work (there will be several boxes that can be filled in)
4. Select Town of East Troy from the drop down of Municipalities (it still works if you leave it as all municipalities, there just may be more info to look through for your specific address)
5. **DO NOT** enter anything other than your **Street Number**, just put in your fire number with no street address and hit enter or find now in the lower right corner.
6. It should pull up your parcel and maybe more.
7. Click on the red parcel number that is for your property.
8. That will bring up your tax information.
9. Scroll down.
10. There will be a red bar that says **Taxes** and just below that are the words **Print Tax Bills**. Click on the year you want the tax bill for and your typical tax bill will appear. **OR**
11. If you want to see if your taxes are paid, look at the chart under Tax History and you will see the history of your tax payments almost up to the minute!
12. If you do NOT have a fire number (aka Street Number), it can be difficult to search by parcel number. The spacing used by the county is often wonky, ie. May look like only one space but it is two, spaces between letters. It is challenging even for us in the office. You can also try by your last name.

Feel free to give us a call and we can email you a copy if need be.

You can pay by mail if you want; the address is on the tax bill. Be sure that first payments are going to the Town of East Troy

NOT Walworth County and that they are payable to the Town of East Troy. If you want a receipt, you **MUST** send a self-addressed stamped envelope.

When you narrow it down, you only get one or just a few options.

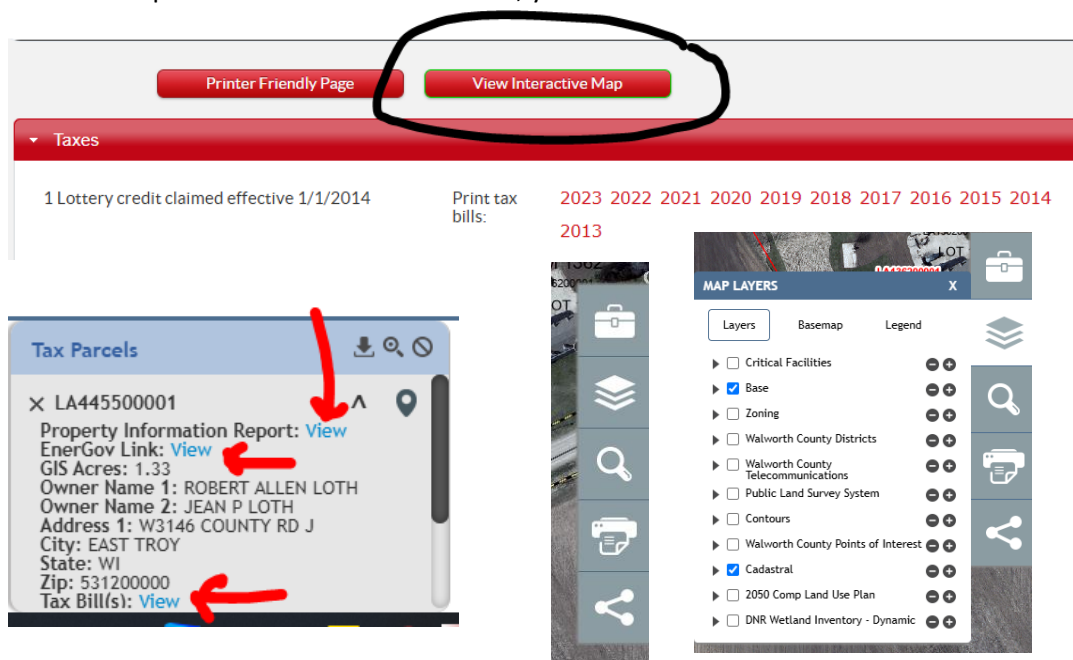

2025 – 2026 Tax Information for Residents of the Town of East Troy

All taxes must be paid in full or the first installment paid on or before - **January 31, 2026**. December postmarks are for income tax purposes, not a property tax deadline.

Options to pay your tax bill: Mail a check or money order made payable to the: Town of East Troy Treasurer:

Drop your payment off at the Town Hall. There is a locked drop box available 24 hours a day in the lobby located on the right-hand side of the second set of doors. A receipt will be mailed, **IF** a stamped, self-addressed envelope is enclosed.

Please include your phone number, so that we can reach you if there are any issues with your check.

A receipt will not be mailed to you. If you require a receipt, please enclose a **STAMPED** self-addressed envelope for a receipt to be mailed to you. Receipts may also be printed from the Walworth County WI website, under Services, Real Estate & Personal Property Search.

NOTE: The Treasurer's office is working on an option to accept credit cards for payments but we do not have a firm date when this will be available. If you are interested in paying by credit card, please contact us for further information.

You may pay your taxes **IN-PERSON** at the East Troy Town Hall located at N9330 Stewart School Road on the following dates:

December 2025 Collection Hours – No Receipts will be issued outside of these times -

December 11, 12, 15 – 19, 22 and 23, 2025 -- 9:00 A.M. to 1:00 P.M.

There will be NO tax collection on December 24, 25, or 26, 2026 and the Town Hall will be closed.

December 29 to December 30, 2025-- 9:00 A.M. to 1:00 P.M.

December 31, 2025 -- 9:00 A.M. to 12:00 P.M. **Town Hall will close at 12:00 P.M.**

January 2026 Collection Hours

The Town Hall will be closed January 1, 2026.

Tuesdays through Thursdays -- 9:00 A.M. to 1:00 P.M.

The Final Day of In-person collection will be January 30, 2026 until 1:00 P.M. Mailed payments postmarked January 31, 2026 will be considered timely. If they are postmarked after January 31, they will be considered late and be subject to interest and penalty charges.

Second Installments

Are payable to the Walworth County Treasurer and must be mailed to the County by July 31, 2026.

Do not mail or drop off your payments at the Town for the Second Installment.

As required by the State of Wisconsin, the Town of East Troy maintains a list of people who submit a request to receive notice of any proposed zoning action that affects the allowable use of the person's property.

If the Plan Commission completes action on any zoning proposal, and the Town Board is prepared to vote on the zoning ordinance, the Town Board shall send a notice, which contains a copy or summary of the proposed zoning ordinance, to each person on the list whose property, the allowable use of which, may be affected by the zoning ordinance. An ordinance may take effect even if the Town fails to send the notice. (Wisconsin Statutes Section 61.35 and 62.23(7)(d)(4).

Dog License Information

Dog License fees must be paid by April 1, 2026 or owners may be subject to a \$5.00 penalty. Please include proof of rabies vaccinations. If you want the tags returned by mail, please provide a self-addressed, stamped envelope otherwise they must be picked up at the Town Hall.

License Fees are: Neutered Males and Spayed Females \$13.00

Unaltered Males and Females \$32.00***
