ORDINANCE No. 2019-1

AN ORDINANCE TO CREATE SECTION 3.07 OF THE ORDINANCES OF THE VILLAGE OF LOGANVILLE.

The Village Board of the Village of Loganville, Sauk County, Wisconsin does hereby ordain as follows:

<u>Chapter 3</u> of the Code of Ordinances, Village of Loganville, Wisconsin, hereby created "Fire Department and First Responders" and shall read as follows:

Section 3.07 Fire Inspections

It shall be the duty of the Fire Chief or his designee to inspect all public buildings and places of employment within the territory of the Loganville Fire District in the Village of Loganville for the purposes of ascertaining and causing to be corrected any conditions liable to cause fire or any violations of law, ordinance, or regulation relating to fire hazards or to the prevention of fires. The Fire Chief is authorized to reduce the frequency of the inspections required by SPS 314.01(13)(b)3,WI Admin Code, to at least once per calendar year, provided the interval between those inspections does not exceed 15 months.

EFFECTIVE DATE:

This ordinance shall be in force from and after its introduction and publication as provided by statute.

3.01 PEACE OFFICERS

Pursuant to 61.31, WI. Stats. The Village President and each Trustee shall be officers of the peace. They may suppress in a summary manner any riotous or disorderly conduct of the street or public places of the Village. They may command assistance of all persons under the same penalty for disobedience provided on 61.28 WI. Stats.

3.02 INSPECT TAVERNS

Village peace officers shall see that each place in the Village that is licensed to deal in fermented malt beverages or intoxicating liquor, is periodically visited and inspected. A record of any violations, complaints or unfavorable conditions shall be maintained. All servers working in such establishments must be licensed and of standing. Licensing is approved by the Village Board yearly.

3.03 FIRES AND ASSEMBLAGES

Peace officers may attend all fires and tumultuous assemblages to direct traffic, to save and protect property, to disperse mobs, and arrest such persons as they may find disturbing the peace or aiding or abating others in so doing.

3.04 ARRESTS, PERSONS CALLED TO ASSIST

All persons in the Village, when called upon by any peace officer, shall promptly aid and assist such officer in the execution of his duties. Failure or neglect to give such assistance shall be, and constitute a violation of this section.

3.05 INTERFERING WITH OR RESISTING PEACE OFFICERS

Any person in the Village who shall willfully resist or in any way interfere with any peace officer in the discharge if his duty or shall hinder or prevent him/her from discharging their duty as such office, shall be subject to the penalty provided in this code.

3.06 PENALTY

Any person who violates any provision of this chapter shall be subject to a penalty as provided in the fines/fee schedule. Or may be subject to arrest.

3.07 SAUK COUNTY SHERIFF'S DEPARTMENT

The Sauk County Sherriff's Department provides protection and coverage for the Village of Loganville. Peace officers may work in conjunction to assist if needed.

3.08 DEFINITION

The village of Loganville together with the Township of Westfield, located in the County of Sauk, State of Wisconsin jointly do hereby establish and agree to pool emergency equipment, services and personnel to provide emergency coverage to both parties. The Fire Department is organized to provide fire protection as required in s.101.575(3)(a)1. Stats.

3.09 COMPSITION OF DEPARTMENTS

Each Department shall consist of volunteers, the LAFD having no less than 22 and no more than 40 members. Each Department shall elect officers yearly according to the department bylaws. The Fire Chief shall have oversight of the LAFD operations, and the safety and training of the members as required by s.101.575(3)(a)1. Stats. The LAFR President shall govern First Responder operations, training and safety of its members.

3.10 AREA OF SERVICE

Coverage area for both departments shall consist of the Village of Loganville and the Township of Westfield. Departments may also provide mutual aid coverage per Department agreements.

3.11 EQUIPMENT

The Village of Loganville will provide housing for all emergency equipment. The Township of Westfield will pay rent for storage according to contract reviewed annually. All equipment purchased and used by either department is the property of the Village and Township per agreement.

3.12 MAINTENANCE AND EXPENSES

All expenses (fuel, oil, tires, insurance, equipment, repairs, etc.) shall be shared with 75% Township of Westfield and 25% Village of Loganville per contract.

3.13 REPORTS

Each Emergency Department shall meet jointly with the Boards of the Village of Loganville and the Township of Westfield. Such meetings will be two times per year at respective meeting halls. Department heads shall provide reports including equipment, training, and budget, including projected needs for budget planning.

3.14 RECORDS

The fire department is responsible to provide all applicable information specified in s. 101.104 (2), shall be filed with the federal agency (NFIRS) and the report shall be filed within 60 days after a call occurs.

3.15 INSPECTIONS

It shall be the duty of the Fire Chief or his designee to inspect all public buildings and places of employment within the territory of the Loganville Fire District in the Village of Loganville for the purposes of ascertaining and causing to be corrected any conditions liable to cause fire or any violations of law, ordinance, or regulation relating to fire hazards or to the prevention of fires.
