# **6.01 LICENSES REQUIRED**

- 1. A License is required for each of the following activities. The license shall be for one year unless otherwise noted and will expire June 30<sup>th</sup>. The fee for each license is in the attachment FEE SCHEDULE
- 2. Application for a license required by this chapter shall be made to the Village Clerk on a form furnished by the Village and shall contain such information as may be required by the State or the Village. Licenses shall be approved by the Village Board as noted in this ordinance.
- 3. License fees must accompany the license application. Once approved the Village Clerk will issue the license to the applicant.
- 4. The words license and permit as used in this chapter shall be interchangeable.

# **6.02 ALCOHOL BEVERAGE LICENSES**

- 1. It shall be unlawful for any person, firm or establishment to sell, keep for sale, deal in or permit to be sold or dealt in to consumers within the Village any alcoholic beverages except in the strict conformance with this ordinance
- 2. The provisions of the Wisconsin Statues shall prevail in application to licenses, permits or forms used for alcohol sales.
- 3. Class A Establishments All Class A Establishments shall be licensed under the provisions of Wisconsin Statutes Section 125 and paying the fee for the Liquor License and the fee for the Fermented Malt Beverage License..
- 4. Class B Establishments All class B Establishments shall be licensed under the provisions of Wisconsin Statutes Section 125 and the fee for the Liquor License and the fee for the Fermented Malt Beverage License see fee schedule.

- 5. Special Class B Gatherings or Picnics All special class B Gatherings or Picnics shall be licensed under the provisions of Wisconsin Statutes Section 125 Wine License and Fermented Malt Beverage License. See fee schedule
- 6. All licenses expire June 30<sup>th</sup>. Renewal of license must be approved by the Village Board prior to expiration date.
- 7. No initial or renewal alcohol beverage license shall be granted for any premises for which taxes, assessments, or other claims to the Village are delinquent and unpaid.

# 6.03 OPERATOR'S LICENSES

- 1. Any eligible person may apply for an Operator's License by paying the fee (see fee schedule) at the time that an application on a form approved by the Village Clerk is submitted to the Clerk or his/her designee. The license will become effective only after is has been approved by the Village Board.
- 2. Pursuant to Wis. Stat. 125.17(5) any individual who has applied for an operator's license as provided by Section 6.02(D)(1) may also apply for a provisional operator's license. This license may be issued by the Village Clerk or an individual designated to act on his/her behalf. It may be issued upon the satisfactory completion of an original operator's license application. The license shall be valid for a period of 60 days from the date of issuance and is intended only to allow the applicant's compliance with the State of Wisconsin's requirement that an applicant complete a responsible beverage server training course prior to the issuance of an operator's license.
- 3. No licensee shall employ any person under the legal drinking age as defined by Wisconsin State Statutes to serve, sell, dispense or give away any alcoholic beverage.

# 6.04 HOURS OF OPERATION - Opening and Closing Hours

- 1. Class A Liquor and/or Fermented Malt Beverage (Retail) Establishments
  - A. Hours for all Class A License Establishments shall be determined by State Law as set forth in Wisconsin Statutes Section 125.
  - B. No intoxicating fermented malt beverages or liquor shall be sold on said premises after said closing hours.
- 2. Class B Liquor and/or Fermented Malt Beverage (Tavern) Establishments

- A. Hours for all Class B License Establishments shall be determined by State Law as set forth in Wisconsin Statutes Sections 125.32 and 125.68 as amended.
- B. No intoxicating liquor shall be consumed upon any licensed premises after said closing hours and said premises shall be promptly vacated at such closing hours by all persons except the owner and his regular employees.
- C. No intoxicating liquor shall be consumed on any property outside the building for which the license is obtained

# 6.05 NUDITY PROHIBITED - Nudity in Licensed Premises Prohibited

- 1. Removal of Clothing Prohibited No person shall remove their clothing so that they shall appear naked or nearly so, whether above or below the waist, in any public room of any premises licensed for the sale of fermented malt beverage or intoxicating liquor in the Village of Loganville or shall any proprietor or licensee of any such licensed premises permit any person to remove his or her clothing so as to appear naked or nearly so, whether a part of a performance, show, entertainment or otherwise.
- 2. Owners, Proprietors, Licensees, Employees, Customers and Entertainers Shall be fully clothed with tops and bottoms when in any public room and of any premises licensed for the sale of fermented malt beverage or intoxicating liquor in the Village of Loganville.

# 6.06 VIOLATIONS - Violations and Penalties

- 1. Owners, Proprietors, Patrons, Licensees, Employees, Customers and Entertainers Any person who shall violate this ordinance shall be fined a sum of not less than Two-Hundred-Dollars (\$200.00) nor more than Five-Hundred-Dollars (\$500.00) for each violation.
- 2. Owners, Proprietors, Patrons, Licensees, Employees, Customers and Entertainers If found guilty of a violation under this ordinance the lines for the offending premises shall stand revoked upon conviction.

# **6.07 CIGARETTE LICENSE**

1. License is required to sell or dispense cigarettes. No person shall sell cigarettes, place cigarette vending machines for public use without obtaining a license from the village

- 2. See fee schedule for cost of licensure for cigarettes
- 3. License must be renewed every year before July 1.

# 6.08 HALL USE

- 1. The Village Hall is available for use for meetings, gatherings and meals with rental agreement.
- 2. There must be a person over 21 years of age in charge of the rental, signing agreement and present at the event.
- 3. No use of tobacco, firearms, or drugs. Alcohol must be served by licensed person or person on premise.
- 4. A refund for rental is given if hall is cleaned and left in good condition.
- 5. In the event of damage to hall or property, the renter will be charged according to damage.
- 6. See fee schedule for hall rent.

# **6.09 PARK USE**

- 1. The park is available at any time for use.
- 2. There is a rental agreement and fee (see fee schedule) if a person wants to rent the park for a gathering or event. This allows for posting private party.
- 3. Use does not include kitchen area.
- 4. Use of lighting for night activity is extra
- 5. Clean up and removal of garbage is required.

#### **6.10 TRAILER PARKS**

1. No trailer parks or camps as defined shall be located, used or maintained or permitted within the Village limits.
