8.01 RULES OF THE ROAD

All Wisconsin and Sauk County rules are hereby adopted for regulation within the village of Loganville. The speed limits set in the Village by the State Department of Transportation shall be enforced. Enforcement of the laws regarding vehicles and traffic shall be done by the Sheriff's Department of Sauk County.

8.02 PARKING

- A. All parking in the Village shall be posted for hours, side of street, etc as set forth by the Village Board.
- B. Parking in Excess of twenty four (24) hours on any street within the village is not allowed. All vehicles must be moved from public streets at least 90' daily. Violation of this shall result in a fine (see fee schedule) plus possible towing and storage costs.
- C. Tractor – trailers in excess of 30 feet may be parked only on Mill or West Street from State St. north. A violation of this section may result in a fine-see fee schedule.
- D. Trucks, Recreational Vehicles, in excess of 10' may only be parked on Main Street to load or unload, not to exceed 1 hour.
- E. Parking prohibited. Except temporarily for the purpose of and while actually engaged in loading or unloading property or passengers and while the vehicle is attended so that it may be moved in case of an emergency. No person shall park or leave vehicle upon:
 - 1. Any part of a highway where parking is prohibited or restricted by sign or yellow line.
 - 2. On a sidewalk or sidewalk area.
 - 3. Upon public or private property, without permission of the owner.

8.03 NON –OPERATIONAL VEHICLES

Abandoned and non-operational vehicles tend to depreciate property values, create a nuisance and offend the aesthetic appearance of a neighborhood.

DEFINITIONS:

"Abandoned Vehicle" is a vehicle allowed to remain parked, standing or stopped on any public place, street, alley or highway for a period in excess of seventy-two hours.

“Non-Operable Vehicle” means a vehicle that is wrecked, junked, unlicensed, dismantled or incapable of operating and is left parked for over seventy-two (72) hours. OR a vehicle allowed to remain parked, stopped upon private property for a period of thirty (30) days and not stored in a garage or other enclosure shielding it from public view.

PROHIBITED CONDUCT

- A. No person shall abandon a vehicle within the village limits.
- B. No person shall permit a non-operable vehicle to remain on public property for more than seventy-two (72) hours or on private property for more than thirty (30) days.
- C. No person owning, occupying, or leasing any premises in the village shall permit an abandoned or non-operable vehicle to remain on the premises more than thirty (30) days.

IMPOUNDING AND JUNKING

Any law enforcement person contacted by the Village of Loganville is hereby authorized to have removed any vehicle abandoned or non-operable by definition.

8.04 SPEED LIMITS

The maximum speed at which a vehicle may be driven upon Village streets is twenty five (25) miles per hour except alleys where the limit is fifteen (15) mph. Maximum speed is posted and regulated on State trunk highways pursuant to Wis Stat. set by DOT

8.05 WINTER PARKING/SNOW REMOVAL

Snow Emergencies: The policy of the Village of Loganville to keep and maintain the streets free of snow and ice in order to provide safe movement of vehicles and persons. Therefore in order to provide snow removal From November 1 to April 1:

- (1.) Downtown - no parking is allowed in the downtown business district of the Village between 3am and 6:30 am. Including Main St. to West St.
- (2.) Remainder of Village - Alternate side parking shall be in effect with odd/even side of street coinciding with the calendar date.

(3). Violators of parking ordinance shall be subject to a forfeiture of a fine (see fee schedule) together with the cost of prosecution, wrecker service and storage of said vehicle.

8.06 SNOWMOBILE USE

A. Private property use – snowmobiles are to be operated only on property belonging to the operator or his family or upon property with permission by the owner to do so.

B. Trails – Snowmobiles may be operated on marked trails approved by the Village Board yearly before November 1.

C. Speed Limit – Snowmobiles must operate in the Village of Loganville no more than twenty (20) miles per hour.

D. Maintenance – Snowmobiles must be well maintained especially mufflers in good condition so as to operate quietly.

E. Violation and Penalty – Any person violating these provisions shall be subject to a fine (see fee schedule).

8.07 SCHOOL BUS

As Provided by WI stat. 349.21(1), the operator of all school busses within the Village of Loganville shall use flashing red warning lights in residential and business districts when pupils or other passengers are to be loaded or unloaded at a location at which there are no traffic signals and such person must cross the street before being loaded or unloaded. Violators passing buses with warning lights, will be prosecuted.

8.08 ATV/UTV USE

Ordinance previously written as 8.09. Designation of ATV/UTV routes within the Village of Loganville. All streets within the village are designated as ATV/UTV routes. Walnut Street (STH 154) from West Village limits and Main Street STH 23/154 from Mill Street to North Village Limits are designated ATV/UTV routes for the purpose of crossing bridges over Narrows Creed provided the operator complies with WI stat. 23.33(11) am3 As Authorized by WI Stats. 23.33(11)4 ATV/UTV routes are designated on the following state highways:

- A. STH 23/154 Main St from Mill St.to Walnut St.
- B. STH 23 Main St from Walnut St. to Peak Hill Road/South St.
- C. STH 154 Walnut St. from West Street to Main St. (STH 23 & STH 23/154

8.09 DISPLAY OF POWER

No person shall make unnecessary and annoying noises with a motor vehicle by squealing tires, excessive acceleration or loud exhaust systems. No use of dynamic braking systems (commonly called Jacob breaking) within the village limits. Exhibiting violations of this ordinance will be subject to a fine (see fee schedule page). Villagers are encouraged to call Sauk County Sheriff's Dept. to report any violations.
