

FROM THE TOWN CHAIRMAN

RED PLATZ

We have been encountering a number of situations lately where residents have been contacted by the Township because they are in violation of our Town of Rhine Ordinances regarding utilization of their properties.

What I am referring to are cases where businesses have been started and are operating on properties that are not zoned properly for business operations or have not requested a Conditional Use Permit from the Town of Rhine to operate the business. When we are made aware of these operations it is our duty to investigate what the circumstances are and determine whether or not we need to take action.

Often times when these situations arise we are put in the position of having to advise the affected parties that they will have to request a rezone of the property and/or apply for a Conditional Use Permit. These requests are not going to be automatically approved by the Planning Commission or the Town Rhine Board simply because someone was unaware of the requirements. If these requests are not granted we will have no choice but to require the business to shut down their operation.

It is the property owner's responsibility to check what they can or cannot do on their property. You can save yourself a lot of trouble by checking our Ordinances, which are on the Town of Rhine website, or by asking a member of the Town Board for clarification if you have any doubts.

While we understand that many people feel that "it is my property and I can do what I want" that is not really the case. Municipality zoning requirements were adopted many years ago to make sure that all residents are treated fairly and can assume that if they live in an area that is predominately zoned for a certain use, that will continue to be the case in most instances.

We would greatly appreciate your cooperation with these matters. If you are in doubt do not be afraid to ask.

SPRING PRIMARY - February 15 (if required, watch for updated info on: myvote.wi.gov)

SPRING ELECTION - April 5

PARTISAN PRIMARY - August 9

GENERAL ELECTION - November 8

REMINDERS:

The State of Wisconsin requires you to show a photo ID for absentee and in-person voting. Please have your photo ID ready when you come to vote.

Voter registration is required at all polling places. You may register to vote prior to election day at the Town Hall or online at "myvote.wi.gov." Proof of residency and a photo ID are required.

In-person absentee voting takes place approximately two weeks prior to each election. Please bring your photo ID.

There is no voting on the Monday before ANY election in the State of Wisconsin.

DOG LICENSES

All dog licenses expire December 31, 2021. 2022 licenses are available mid-December.

The fee is \$7 for spayed/neutered dogs and \$14 for unaltered dogs. A current rabies certificate is required to obtain a license.

A late fee of \$20 is charged if dogs are not licensed by April 1, 2022. Please note the maximum number of dogs per parcel is four


Make checks payable to: Town of Rhine.

Dog license fees cannot be combined with any other payments.

Submit fee and rabies certificate in person, by mail, or in the drop box to the left of the Town Hall front door.

As a dog owner you are required to vaccinate, license, and keep control of your dog.

Failure to do any of the above is a violation of State and local laws and is subject to fines.
