ORDINANCE 08.2025 AMENDING CLASSIFICATION OF AND WEIGHT LIMITATIONS ON TOWN HIGHWAYS ORDINANCE

The Town Board of the Town of Polk, with quorum present and voting, hereby ordains the following amendments to § 321-6 of the Town of Polk's Code of Ordinances, titled "Classification of and Weight Limitations on Town Highways":

\S 321-6 B. (1) is amended to read as follows:

Ten-ton limit. A special vehicle weight limitation of 10 tons is hereby imposed on the following Town roads:
