## Tax Collections

**December payments must be postmarked by December 31, 2025, to be considered timely. (please ask the postmaster to hand postmark, mail placed in the post office or collection container are not guaranteed to be postmarked for same day) Payments must be postmarked by January 31, 2026, to be considered timely.**

2<sup>nd</sup> Installment Payments are payable to: Dodge County Treasurer.

### In Person Tax Collections:

#### Farmers & Merchants Union Bank

You may pay tax bills at both FMUB locations in Columbus, during regular business hours. **You Don't have to bank there to pay your taxes there.**

\*Make sure to bring the tax stubs for each parcel to ensure proper payment application.

\*Please note: if you have an escrow or other check that is greater than the balance of the tax bill. The bank will NOT be issuing refunds. The Town Clerk will issue reimbursements after the next town board meeting.

### Town of Elba - Real Estate Market Update

Public Informational Meeting Tuesday January 20, 2026, at 6:30pm at the Town of Elba Town Hall

The State of Wisconsin notified the Town of Elba that our Real Estate values are not in compliance, which means that the State determined actual value of the properties within the Town of Elba are currently assessed at 25% less than their actual value.

Frank Assessments will hold a public informational meeting on the market update process; all are welcome and encouraged to attend.

## Town Hall Collections

There will be in-person tax collections at the Town Hall this year. They will be:

Wednesday, January 28 <sup>th</sup>	1pm-6pm

You may place payments in the drop box at the Town Hall anytime. If you would like a receipt, please include a self-addressed **STAMPED** envelope. Otherwise, in person payments are accepted at Farmers & Merchants Bank in Columbus.



## DID YOU RECEIVE LOTTERY & GAMING CREDIT?

If you do not have a Lottery & Gaming credit on your tax bill you may still be eligible.

**To Qualify:** You must own a home in Wisconsin, you must have occupied the home and be the PRIMARY resident on January 1, 2025.

- a. A primary residence is the home in which a property owner lives for more than six months of the year.
- b. If temporarily away, a primary residence is the home to which the owner returns.

If you feel you qualify for the credit, and there is not a lottery credit on your tax bill, please plan to come to the Town Hall on one of the collection days to get the adjustment made.
