

Ordinance No. 04-2012

**AN ORDINANCE TO ADOPT AMENDMENTS TO THE
CALUMET COUNTY YEAR 2025 SMART GROWTH PLAN AND THE
TOWN OF WOODVILLE EXPANDED LAND USE ELEMENT**

The Town Board of the Town of Woodville, Calumet County, Wisconsin, does ordain as follows:

SECTION 1. On Sept 5, 2007, the Town of Woodville adopted the *Calumet County Year 2025 Smart Growth Plan* and the *Town of Woodville Expanded Land Use Element* in accordance with Section 66.1001, Wis. Stats.

SECTION 2. Section 66.1001 (2)(i), Wis. Stats. states that a comprehensive plan shall be updated no less than once every 10 years.

SECTION 3. The Calumet County Planning, Zoning and Land Information Department conducted a 5-year update to coincide with the release of the 2010 U.S. Census.

SECTION 4. The plan amendments include, but are not limited to: text, table, chart and map amendments to reflect available updated statistical and factual data, updates to land use and service matters, and identification of accomplishments achieved in the Implementation/Action section of the town's land use element.

SECTION 5. The Calumet County Planning, Zoning, and Farmland Preservation Committee held a public hearing on January 11, 2012, regarding amendments to the *Calumet County Year 2025 Smart Growth Plan* and the *Town of Woodville Expanded Land Use Element*. The Committee reviewed and incorporated public comments into the plan.

SECTION 6. On February 1, 2012, the Town of Woodville Plan Commission adopted a resolution recommending to the Town Board of the Town of Woodville adoption of the amendments to the *Calumet County Year 2025 Smart Growth Plan* and the *Town of Woodville Expanded Land Use Element*.

SECTION 7. On February 21, 2012, the Calumet County Board of Supervisors adopted the amendments to the *Calumet County Year 2025 Smart Growth Plan*.

SECTION 8. The Town of Woodville Town Board held a public hearing on May 9th, 2012 to review the amended *Calumet County Year 2025 Smart Growth Plan* and the *Town of Woodville Expanded Land Use Element* in compliance with the requirements of Section 66.1001(4)(d), Wisconsin Statutes.

SECTION 9. The Town Board of the Town of Woodville does, by the enactment of this ordinance, formally adopts the amended *Calumet County Year 2025 Smart Growth Plan* and the *Town of Woodville Expanded Land Use Element* pursuant to Section 66.1001(4)(c), Wisconsin Statutes.

SECTION 10. This ordinance shall take effect upon passage by a majority vote of the members-elect of the Town Board and publication/posting as required by law.
