LOCAL LAW NUMBER 1 0F 2008

OF THE TOWN OF HAMMOND

A LOCAL LAW ENACTING A MORATORIUM ON THE SITING OF WIND TURBINES WITHIN THE TOWN OF HAMMOND.

Section 1. Purpose and Legislative Intent

The Town of Hammond is currently studying the effects on the community of the utilization of wind power. The study is being conducted by a committee duly appointed by the Town Board of the Town of Hammond. At this time, no application for permits to construct wind towers or turbines have been received by the Town. This moratorium is meant to and does prohibit the application for, or issuance of, Special Use Permits or Building Permits with respect to construction of wind towers or turbines. In addition, no person shall be permitted to site, place, build, construct, modify or prepare any site for the placement or use or use of, wind towers or turbines.

Section 2. Relief from Moratorium.

Affected landowners may apply for relief from this moratorium directly to the Town Board, Town of Hammond. All such requests shall be in writing. The Town Board shall, within 30 days of a request for such relief, issue a decision to the affected landowner stating whether or not such relief will be granted.

Section 3. Conflict with Other Laws

Where this Local Law differs or conflicts with other Laws, rules and regulations, unless the right to do so is preempted or prohibited by the Town, State or Federal government, this Local Law shall apply.

Section 4. Effective date and Duration.

This Local Law shall be effective immediately upon passage, pursuant to applicable legal and procedural requirements. This moratorium (Local Law) shall remain in effect for a period of eight months, (240 days), from the effective date.

Section 5. Authority

This Local Law is enacted pursuant to applicable authority granted by the State and Federal government.
