Be it enacted by the Town Board of the Town of Hammond as follows:

Section 1.

There is hereby established a moratorium on applications for the review and approval of permits for Wind Energy Facilities within the Town of Hammond. During the moratorium period, no applications for the review and/or approval for the siting, construction or placement of Wind Energy Facilities within the Town of Hammond shall be accepted and no review of proposed Wind Energy Facilities shall be conducted by the Planning Board.

Section 2.

The period of the moratorium established by this Local Law shall be six (6) months from the effective date of this Local Law.

Section 3.

This Local Law shall take effect upon the filing with the Secretary of State as required by the Municipal Home Rule Law.
