- Article 1. Authority. The Town Board of the Town of Hammond, pursuant to the authority granted it under Section 130 of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:
- Article 2. Statement of Purpose and Findings. The Town Board of the Town of Hammond has determined that the case load in Town Justice Court can be easily handled by a single justice and therefore it is in the best interests of the residents of the Town of Hammond to eliminate one Town Justice position upon expiration of current term effective December 31, 2021.
- <u>Article 3. Enactment</u>. The Town Board of the Town of Hammond hereby eliminates one of the two Town Justice position upon the expiration of the current term effective December 31, 2021.
- Article 4. Severability. If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.
- Article 5. Permissive Referendum. This local law is adopted subject to a permissive referendum.
 - Article 6. Effective Date. Upon expiration of the referendum period or in the event a referendum is called and the local law is approved by a majority of eligible voters voting in such referendum, this local law shall be effective on December 31, 2021.
