A Local Law electing to opt out of Section 487 of the New York State Real Property Tax Law as amended.

Be it enacted by the Town Board of the Town of Hammond as follows:

Section 1:

The Town of Hammond hereby opts out of Section 487 of the Real Property Tax Law as amended, and therefore provides that no exemption shall hereafter be provided under that Section for any property located within the Town of Hammond.

Section 2:

In addition to the normal filing requirements for local law, the Town Clerk shall file a copy of this Local Law with the President of the New York State Energy Research and Development Authority, and the Commissioner of Taxation and Finance.

Section 3:

This law shall be effective upon filing with the Secretary of State in accordance with the Municipal Home Rule Law.
