Local Law No. 1 of the year 2018

A Local Law to establish a moratorium on any application for site plan review for land use activity within the Town of Hammond with the exception of food service establishments to allow the Town Board of the Town of Hammond sufficient time to review its Site Plan and Subdivision Review Law and to revise regulations that need more specificity to ensure the health, safety and welfare of the residents of the Town of Hammond.

Be it enacted by the Town Board of the Town of Hammond as follows:

**Section 1. AUTHORITY.** This local law is adopted pursuant to Article 16 of the Town Law, the New York State Executive Law, §10 of the Municipal Home Rule Law; and Section IX of the New York State Constitution.

**Section 2. INTENT and PURPOSE.** The Town Board of the Town of Hammond hereby determines that the Hammond Site Plan and Subdivision Review Law, as it is currently written may inadequately address certain conditions and regulations relative to certain land use activities. The Town Board intends to review and revise those regulations to be more specific and protect the health, safety and (28770/23890/DEC/01538106.DOC)

welfare of its residents. In order to allow the Town sufficient time to conduct such a review and make appropriate revisions, it is the finding of the Town Board that it is necessary to provide a moratorium of six (6) months on all applications for site plan approval with the exception of food service establishments, pending the adoption of said regulations.

**Section 3.** The Town Board of the Town of Hammond hereby enacts a moratorium on all applications for site plan within the Town with the exception of applications in connection with food service establishments. The siting, locating, application for review of any application for such uses shall be suspended for six (6) months as of the effective date of this law while the Town Board considers the adoption of further regulation with respect to such uses.

**Section 4. SEVERABILITY.** If any section, paragraph, subdivision, clause or provision of this local law shall be adjudged invalid, such judgment shall apply only to such section, paragraph, subdivision, clause or provision so adjudged, and shall not affect, impair, or invalidate any other part or portion of this local law.

**Section 6. EFFECTIVE DATE.** This local law shall take effect upon filing with the Secretary of State.
