Amendment to Resolution 2025-1 Siting Resolution for
Expansion of Timberline Trail Recycling and Disposal Facility
(changes the name and address of committee member, Tom Cudo to David Kochendorfer)

The Town Board of the Town of Stubbs, Rusk County, Wisconsin, located at N3305 S Hutchinson Rd. Bruce, WI 54819, by this resolution, adopted by a majority of the town board with a quorum present and voting and proper notice having been given, resolves and orders as follows:

WHEREAS, the Town, on December 19, 2024 received a Request for Local Approvals for expansion of Waste Management of Wisconsin, Inc.'s Timberline Trail Recycling and Disposal Facility;

WHEREAS, the applicant identified above is located at N4581 New Hutchinson Rd, Weyerhaeuser, WI 54895;

AND WHEREAS, the specific location of the proposed expansion is to be located at the legal description as follows:

Part of the South $\frac{1}{2}$ of the Northeast $\frac{1}{4}$ and the Southeast $\frac{1}{4}$ of Section 4, Township 34 North, Range 8 West in the Town of Stubbs, Rusk County, Wisconsin, bounded and described as follows:

Commencing at the Northeast corner of said Section 4, Township 34 North, Range 8 West; thence SOI $0^{\circ}01'40''$ W, 1926.48 feet along the East line of said Northeast $\frac{1}{4}$ of Section 4; thence N88 $^{\circ}07'34''$ W, 378.83 feet to the point of beginning of lands to be described; thence continuing N88 $^{\circ}07'34''$ W, 1412.09 feet; thence S00 $^{\circ}10'04''$ E, 916.49 feet; thence s00 $^{\circ}08'04''$ W, 1093.01 feet; thence S44 $^{\circ}31'57''$ E, 333.32 feet; thence S00 $^{\circ}46'26''$ E, 169.57'; thence s00 $^{\circ}11'44''$ W, 962.26 feet; thence S89 $^{\circ}58'17''$ E, 1069.18 feet; thence N24 $^{\circ}05'01''$ E, 460.00 feet; thence N00 $^{\circ}24'58''$ W, 404.04 feet; thence S89 $^{\circ}21'50''$ W, 282.39 feet; N59 $^{\circ}49'58''$ W, 171.78 feet; thence N00 $^{\circ}10'54''$ W, 574.32 feet; thence N40 $^{\circ}15'05''$ E, 558.62 feet; thence N00 $^{\circ}10'01''$ W, 551.81 feet; thence N00 $^{\circ}08'25''$ W, 873.63 feet to the point of beginning. Said parcel contains 63,606 \pm square feet or 95.58 \pm acres.


