## ORDINANCE NO. 2018-01

# AN ORDINANCE TO CODIFY CHAPTERS 1 THROUGH 11 OF THE TOWN OF COTTAGE GROVE CODE OF ORDINANCES

### RECITALS

- A. The Partial Code of the Town of Cottage Grove Code of Ordinances attached as Attachment A, and consisting of Chapters 1 through 11 ("Partial Code"), have been revised, codified, and consolidated.
- B. Pursuant to Wis. Stat. § 66.0103, the Partial Code has been prepared and has been on file and available for public inspection in the Town Clerk's office for more than two weeks.
- C. The Town Board of the Town of Cottage Grove has determined that it is in the public interest to adopt the Partial Code by reference, as provided in Wis. Stat. § 66.0103.

### **ORDINANCE**

NOW THEREFORE, pursuant to Wis. Stat. § 66.0103, the Town Board of the Town of Cottage Grove do ordain as follows:

- 1. The Partial Code, consisting of Chapters 1 through 11, attached as Attachment A, is adopted.
- 2. This ordinance and the Partial Code shall supersede all other general and permanent ordinances enacted as part of Chapters 1 through 11 prior to the enactment of this Partial Code.
- 3. It shall be the duty of the Town Clerk, or someone authorized and directed by the Town Clerk, to keep up-to-date the certified copy of the Partial Code required to be filed in the Town Clerk's office for use by the public. All changes in the Partial Code and all ordinances adopted subsequent to the effective date of this codification which shall be adopted specifically as part of the Partial Code shall, when finally adopted, be included therein by reference until such changes or new ordinances are included as supplements to the Partial Code.

- 4. The adoption of this ordinance shall not affect the following rights and obligations, which are hereby expressly saved from repeal:
- a. Any right or liability established, accrued or incurred under any legislative provision prior to the effective date of this ordinance or any action or proceeding brought for the enforcement of such right or liability.
- b. Any offense or act committed or done before the effective date of this ordinance in violation of any legislative provision or any penalty, punishment or forfeiture which may result therefrom.
- c. Any prosecution, indictment, action, suit or other proceeding pending or any judgment rendered prior to the effective date of this ordinance brought pursuant to any legislative provision.
- d. Any franchise, license, right, easement or privilege heretofore granted or conferred.
- e. Any ordinance providing for the laying out, opening, altering, widening, relocating, straightening, establishing grade, changing name, improvement, acceptance or vacation of any right-of-way, easement, street, road, highway, park or other public place or any portion thereof.
- f. Any ordinance appropriating money or transferring funds, promising or guaranteeing the payment of money or authorizing the issuance and delivery of any bond or other instruments or evidence of the Town's indebtedness.
- g. Any ordinances authorizing the purchase, sale, lease or transfer of property or any lawful contract or obligation.
  - h. The levy or imposition of taxes, assessments or charges.
- i. The annexation or dedication of property or approval of preliminary or final subdivision plats.
- j. Ordinances providing for local improvements or assessing taxes or special assessments.
- k. All currently effective ordinances pertaining to the rate and manner of payment of salaries and compensation of officers and employees.
- 1. Any legislation relating to or establishing a pension plan or pension fund for municipal employees.

- m. Any ordinances adopting or amending the Zoning Map or otherwise rezoning property.
  - n. Any charter ordinance.
- o. Any ordinance or portion of an ordinance establishing a specific fee amount for any license, permit or service obtained from the Town.
- 3. This ordinance shall take effect upon passage and publication as required by law.
