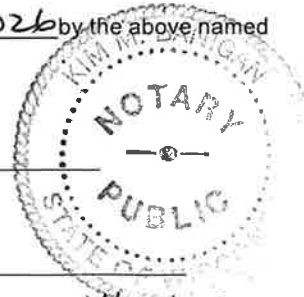

Renaming a small section of Gaston Road as East Gaston Road

WHEREAS, on September 15, 2025, the Village of Cottage Grove annexed territory from the Town of Cottage Grove that included almost all of the right-of-way of Gaston Road east of County Highway N, but left a small portion of the right-of-way in the Town of Cottage Grove, and

WHEREAS, the Village of Cottage Grove named the road East Gaston Road based on their naming requirements, and

WHEREAS, confusion for 911 and NG911 requirements of the State are created by having the Village portion of the road named East Gaston Road and the Town portion of the road named Gaston Rd,

NOW, THEREFORE, BE IT RESOLVED that the Town of Cottage Grove is renaming an approximately eighty-two foot portion of GASTON ROAD located in the Northeast Quarter of the Northeast Quarter of Section 4, Township 07, Range 11; to EAST GASTON ROAD, see map attached.
