## CITY OF WISCONSIN DELLS - OFFICIAL NOTICE NOTICE OF PUBLIC HEARING - 2026 PROPOSED BUDGET

Notice is hereby given that in accordance with Section 65.90(4) of the Wisconsin Statutes, the Common Council of the City of Wisconsin Dells will hold a Public Hearing in the Common Council Chambers of the Municipal Building, located at 300 La Crosse Street on Monday, November 17, 2025 at 6:30 P.M. on the Proposed 2026 General Fund & Debt Service Budget. All interested citizens will have the opportunity to give written and oral comment.

The 2025 estimated City tax levy rate for the proposed 2026 budget per \$1,000 of assessed valuation and various comparison levy rates of 2024, 2023, 2022, 2021, 2005, 1996 and 1992, are shown below. The estimated average tax levy rate for 2025 is \$8.03/M as compared to \$8.09/M for 2024. The tax levy amount for 2025 is \$3,641,710. This is a decrease of .61% or \$22,355 less than the 2024 tax levy amount.
