

## RESOLUTION NO. 2021-01

### A RESOLUTION OF THE TOWN OF GENOLA APPOINTING A REPRESENTATIVE TO THE SOUTH UTAH VALLEY ANIMAL SERVICES SPECIAL SERVICE DISTRICT

WHEREAS, the Board of County Commissioners of Utah County and several cities in Utah County initiated proceedings to create a special service district to provide consolidated animal services within south Utah County to be known as the South Utah Valley Animal Services Special Service District (the "District");

WHEREAS, the Town of Genola is a member of the District;

WHEREAS, the Town Council of Genola would like to make a new appointee to the Board of the District; and

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF GENOLA, UTAH:

1. Appointment of Representative. The Town Council of Genola hereby appoints Rodney Hurst as its representative to the Board of Trustees of the South Utah Valley Animal Services Special Service District.
2. Appointment of Alternate Representative. The Town Council of Genola hereby appoints Mike Wall as its alternate representative to the Board of Trustees of the South Utah Valley Animal Services Special Service District. The alternate representative shall have no vote unless the Member's representative to the Board of Trustees is absent. In the event the Member's representative to the Board of Trustees is absent, the alternate representative shall exercise all of the powers and authorities of the Member's representative to the Board of Trustees.
3. Continuation of Appointment. The appointment shall remain in effect until repealed by another resolution appointing a different representative to the South Utah Valley Animal Services Special Service District, or until the representative is no longer qualified.
4. Effective date. This resolution shall become effective upon passage.
5. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the Town of Genola conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.
