20.25.01	SHORT TITLE

This Ordinance shall be known and may be cited as the "**Genola Town Digging Permit Ordinance.**"

#### 20.25.02 CONDITIONS OF PERMIT

Any and all work performed within a Genola Town right-of-way shall conform to the list of requirements of this section, the Genola Town Standards, Genola Town Engineering Standards as determined by the Public Works Department and/or the Town Engineer, Design Standards, Construction Specifications and traffic control regulations of the Town of Genola. If it is deemed necessary to have the work plan reviewed by the Genola Town Engineer, the person or entity requesting the permit shall cover the costs of such review. Compliance with this section will be determined by the Genola Town Public Works Department and/or the Board supervisor over Public Works.

## List of Requirements

- 1. Person or entity performing such work within a Genola Town right-of-way shall be licensed as a contractor within the State of Utah. An exception to this requirement may be granted by the Town Board.
- 2. A copy of the current Contractor License shall be provided to the Town.
- 3. Proof of insurance shall be provided with a minimum coverage of \$1,000,000.00 general liability, \$1,000,000.00 bodily injury and \$1,000,000.00 property damage.
- 4. A work plan detailing the work to be completed shall be provided to Genola at least forty-eight (48) hours prior to date of anticipated work.
- 5. All construction shall be made available for inspection by Genola Town officials.

## 20.25.03 **PERMIT REQUIRED**

Any person or entity planning on performing work within a Genola Town right-of-way shall first obtain a permit issued by the Town of Genola at least forty-eight (48) hours prior to the anticipated date of work commencement.

# 20.25.04 **BOND REQUIRED**

A \$1,000.00 cash bond is required to be posted with the Clerk of the Town of Genola at least forty-eight (48) hours prior to the commencement of any work within the Genola Town right-of-way. This bond shall be retained for a period of one (1) year after completion of construction to act as a warranty against failure. In the event of major failure of performance, the Town of Genola reserves the right to bill said person or entity for the cost associated with the failure as well as the right to pursue any legal means necessary to collect such sums.

#### 20.25.05 **FEE**

All permits issued hereunder shall require the corresponding fee that is itemized in the Genola Town Fees and Budgetary Guidelines Resolution.

#### 20,25.06 **PERIOD OF USE**

A dig permit is valid only for the dates indicated on the permit and may be given for a maximum of four weeks. A new permit must be obtained once a permit has expired.

### 20.25.07 VIOLATIONS AND PENALTY

Failure to obtain a permit, failure to post bond, failure to give notice and/or failure to obtain proper city inspections all constitute separate violations under this Ordinance and shall be considered each a Class B Misdemeanor.
