

Resolution No. 2026-01

A RESOLUTION ESTABLISHING AN ANNUAL MEETING SCHEDULE FOR 2026

WHEREAS, the "Utah Municipal Code," Utah Code Ann. § 10-3-502, provides that the council of each municipality of the State of Utah prescribe the time and place for holding its regular meeting by ordinance;

WHEREAS, the "Open and Public Meetings Act," Utah Code Ann. §52-4-202, provides that the public body give public notice of its annual meeting schedule;

WHEREAS, the Town Council of the Town of Genola desires to prescribe an annual meeting schedule for 2026;

NOW THEREFORE, be it resolved by the Town Council of the Town of Genola:

1. The Town Council of the Town of Genola will generally meet on the following dates in 2026, with meetings to begin generally at 7:00 p.m. in the Town of Genola Public Safety Building:

January 21	May 20	September 16
February 18	June 17	October 21
March 18	July 15	November 18
April 15	August 19	December 9

2. The Planning Commission of the Town of Genola will generally meet on the following dates in 2026, with meetings to begin generally at 7:00 pm in the Town of Genola Public Safety Building:

January 8	May 7	September 3
February 5	June 4	October 1
March 5	July 2	November 5
April 2	August 6	December 3

3. When there are agenda items, the Development Review Committee of the Town of Genola will generally meet on the same 2026 dates as the Planning Commission, with meetings to begin generally at 6:00 pm in the Town of Genola

4. Effective Date. This resolution shall become effective upon publication.
5. Repeal of Conflicting Resolutions. To the extent that any resolutions or policies of the Town of Genola conflict with the provisions of this resolution, they are hereby amended to be in accordance with the provisions hereof.


