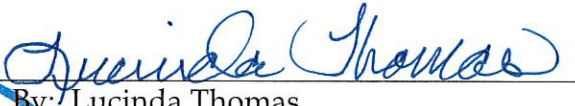

Calculated Building Permit Fee

Building Permit Fees shall be paid at the time the plans are submitted to the Town for review. Building Permit fees shall be calculated based upon the value of the structure. The value is calculated by multiplying the square footage of the building by the *Valuation per Square Foot* identified in the table below. The Building Permit Fees are then calculated by multiplying the building valuation by the applicable multipliers in the table below.

The Building Inspector will calculate all applicable fees, which shall be paid prior to the Town incurring any additional review and engineering fees, and no later than the time at which the Building Permit is issued.

Remodel Permit Fee

Building Permit Fees related to remodel construction are charged \$75.00 per required inspection by the Building Inspector. The Town will charge a \$300 up-front deposit for the inspections. If after four inspections by the Building Inspector additional inspections will still be required, the Building Inspector will red tag the remodel until the applicant pay an additional deposit equal to \$75.00 per additional inspections the Building Inspector anticipates will be required. If the remodel is completed and approved by the Building Inspector with fewer than four inspections, the Town will issue a refund check to the applicant in the amount of \$300.00 less the fee.
