A RESOLUTION OF THE TOWN OF GENOLA
APPROVING AGREEMENT 2025-10
INTERLOCAL COOPERATION AGREEMENT WITH UTAH COUNTY
FOR THE 2025 RECREATION GRANT

WHEREAS, the Utah Local Cooperation Act, set out in Utah Code Ann. § 11-13-101 et seq. (the “Act”) provides that local governmental entities are authorized to enter into agreement with each other, upon resolution of the governing body of each of the parties, to do what each entity is authorized by law to perform;

WHEREAS, the Town of Genola and Utah County are governmental entities as contemplated in the Act;

WHEREAS, the Town Council of Genola has determined that it is in the best interests of the citizens of the Town to enter into an Interlocal Cooperation Agreement with Utah County for a 2025 Recreation Grant; and

WHEREAS, an Agreement (Genola Agreement No. 2025-10) has been prepared for approval and execution by the Town of Genola;

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF GENOLA, UTAH:

1. Approval of Agreement. The Town Council hereby approves the attached Agreement “2025 RECREATION GRANT AGREEMENT BETWEEN UTAH COUNTY AND THE TOWN OF GENOLA” by and between Utah County and the Town of Genola, and the Mayor and Town Recorder are authorized and directed to execute the attached Agreement on behalf of the Town of Genola;
2. The Agreement shall be identified in the Town of Genola as Interlocal Cooperation Agreement 2025-010;
3. Pursuant to Utah Code Annotated §11-13-209, a duly executed counterpart of said Interlocal Agreement shall be filed with the Town Recorder;
4. The Interlocal Cooperation Agreement shall become effective upon execution by all of the parties thereto;
5. Repeal of Conflicting Resolutions. To the extent that any resolution previously adopted by the Town of Genola conflicts with the provisions of this Resolution, it is hereby amended, invalidated or, replaced by the provisions hereof; and

6. Effective date. This resolution shall take effect immediately, as authorized by §10-3-719 of Utah Code Annotated.

**2025 RECREATION GRANT AGREEMENT BETWEEN UTAH COUNTY AND
THE TOWN OF GENOLA**

This Agreement is made and entered into by and between Utah County, a political subdivision of the State of Utah, with its office located at 100 East Center Street, Provo, Utah, 84606, hereinafter referred to as COUNTY and the TOWN OF GENOLA, with its office located 74 W 800 S, Genola, Utah 84655, hereinafter referred to as CITY.

RECITALS

WHEREAS, the Board of County Commissioners, Utah County, Utah has adopted policy guidelines and procedures for approving applications for Utah County Municipal Recreation Fund Grants which comply with the provisions of Title 59, Chapter 12, Part 6, Utah Code Annotated, 1953 as amended; and

WHEREAS, COUNTY has reviewed the Utah County 2025 Municipal Recreation Grant Application submitted by CITY and has determined that CITY should be awarded a Utah County Municipal Recreation Grant.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein, it is agreed by and between COUNTY and CITY as follows:

1. COUNTY hereby agrees to make a 2025 Municipal Recreation Grant to CITY in an amount not to exceed \$5,000.00 through funds derived from the Tourism, Recreation, Cultural and Convention Facilities Tax of the County of Utah for the purpose of the North Pavillion Picnic Table Completion Project.
2. CITY hereby agrees that the grant received from COUNTY shall be used exclusively in funding the above-mentioned project.

3. The parties agree that all funds granted herein by COUNTY to CITY shall be given only for documented reimbursable costs incurred by CITY for the purpose stated above, and that payments by COUNTY to CITY will be made only upon presentation by CITY to COUNTY of appropriate receipts or other permitted documentation of reimbursable costs made by CITY. The reimbursement period will take place from January 1, 2026, through June 30, 2026, and will be made upon CITY presenting all appropriate receipts or other permitted documentation to COUNTY.
4. CITY also agrees that all publicity generated by CITY for the approved project shall display the language, "Sponsored in part by the Utah County Community Activities Fund."
5. The parties agree that COUNTY by virtue of this Agreement is making a grant only to CITY and is not responsible for any actions of CITY, or any other entity, in the construction of the project and the completion of the project stated above.
6. It is agreed by the parties that COUNTY may audit the records of CITY concerning the above-mentioned approved project at any time.
7. It is agreed by the parties that this Agreement shall be governed by, construed, and enforced in accordance with the laws of the State of Utah.
8. This Agreement shall constitute the entire agreement between the parties and any prior understanding or representation of any kind preceding the date of this Agreement shall not be binding upon either party except to the extent incorporated in this Agreement.
9. Any modification of this Agreement or additional obligation assumed by either party in connection with this Agreement shall be binding only if placed in writing and signed by each party or an authorized representative of each party.
