270-2 (E) Any such culverts or driveways installed pursuant to this section or installed with a permit or fee required under this section, for that portion of the driveway and culvert extending from the owner's property line to the road right-of-way may be constructed of asphalt, stone and gravel, or some other similar construction materials that allow for relatively easy destruction, removal and reconstruction. If concrete or cement is used, the Town is not responsible for the replacement of said concrete or cement. The property owner must replace the pavement if culvert repair is necessary.
