The County of Door has implemented a new tax program, therefore the previous program used by the town will no longer be available. Beginning December 2024 all property tax payments will be processed by the Door County Treasurer's office.

If paying by mail please include your check and the first installment or full payment stub from the bottom of your tax bill.

Payments to be credited in 2024 must be postmarked by December 31, 2024. All other payments must be postmarked by January 31, 2025 or payment will be considered delinquent for the 1st installment.

Payments can now be viewed on the Door County website as soon as payment is processed.

Dog Licenses will continue to be issued by the Town of Union. All dog licenses expire on December 31, 2024 and must be paid on each dog over the age of 5 months.

LEGAL NOTICE: Any lodging provider offering transient rental (less than 30 days) must obtain a permit and collect 8% room tax (per WI State statute, local ordinance, and the Door County Tourism Zone Intergovernmental Agreement). Please be aware that the activities listed below are regulated under county shoreland and floodplain zoning ordinances:

- In shoreland and floodplain areas, placement or construction of most structures, including sheds, regardless of size or permanence
- Structures and/or hard surfaces such as patios, decks, gravel areas, permanent firepits or fireplaces, particularly within 300' of the ordinary high water mark
- 3. Tree cutting/trimming and other vegetation removal along the shoreline

Permits may be required – or the activity may be disallowed entirely on your property – so please contact Door County Land Use Services at (920)746-2323 for more information before you embark upon these activities. Maps of shoreland and FEMA flood hazard areas may be found on-line at http://map.co.door.wi.us/map/ Please note that outside of those areas town permits may be required for such structures.
