- **The Town Chairman shall approve all culverts prior to construction of the driveway.**
- Culverts shall be installed as part of the construction of the driveway.
- Culverts shall be a minimum of 12 inches in diameter

REQUIREMENTS:

- Driveways shall be at least sixteen (16) feet wide, have not less than fourteen (14) feet of hard surfacing with one (1) foot shoulders on either side and an overhead clearance of fifteen (15) feet so fire and emergency equipment can enter unobstructed.
- The setback for any driveway must be a minimum of five (5) feet from the property side lot line unless the driveway is to be shared by the adjacent property owner.
- No more than two (2) single family houses or two (2) commercial or industrial buildings shall be served by a shared driveway. Access for more than two lots or parcels to a road or permanent access easement via any shared driveway shall not be approved unless the Town Board determines that a shared driveway is necessary for environmental or safety reasons, and must be equal to Town Road standards.
- Driveways shall not be constructed so as to impair drainage, and culverts shall be large enough and properly placed to accommodate adequate water movement and transport of emergency vehicles.
- Driveways in excess of 50' in length which are not straight, shall be provided a turnaround for emergency vehicles.

ATTACHMENTS:

- **A site plan indicating lot size, the proposed driveway, any existing buildings, distances between buildings and the centerlines of all abutting roads, ordinary high-water mark and lot lines.**
- **A permit fee of \$40.00. Make check payable to the Town of Union.**
