PUBLIC COMMENT/INPUT

Alderman Smith stated that, regarding the Bartlett House and budget in general, on the revenue side, tax collection in Olean has flat lined, while expenses keep increasing. He cannot stress enough how tight the budget is and how much tighter it will be in the future.

Dave Hornburg, the former Olean Historical Society President, stated that Mr. Deckman has been wonderful. He is an unsung hero and is the glue that is keeping things together at the Bartlett House. It was a miracle when the house was acquired years ago, and it took many volunteers hundreds of hours of work and love to restore. The Historical Society stands by the City, and would like to help work with the City to allow the House to be fully utilized.

*Della Moore stated that people come from all over to see the House and to learn about history, both theirs and ours. She knows that the budget was cut to the bare bones, and thanks the benefactor for their generous donation. If a different organization cannot come in and take over, she recommends supports putting together pledges to try to keep the House running. *

Anne Walsh, the former City Historian and Director of the Bartlett House, stated that she is part of the team that originally put the house together. She is very grateful and thankful for the donation as well. Her remaining concern is that within the next year, we need to work on budget issues and find a solution. Everyone needs to work together. She feels that the Council needs to be more up front. History is far too important. She doesn't want to see this swept under the carpet until next year. We need to work on a long term solution now.

Paula Swier of 326 South Union Street stated that she was appalled to read that the budget for the House was being cut. She doesn't understand how it came up out of the blue. It is too amazing of an entity for our community. We have an awful lot of history in our town, and she is certain that there is still a lot there to preserve. If another entity wants to take on the Bartlett House, we should bring them on board. She feels that this was a horrible solution to the blight issue, to get rid of something so wonderful.

Melissa Knicks of Ischua thanked Mr. Deckman and his wife for their service to the history of Olean. His position and this House are worth preserving to perpetuate for younger people. We are all fortunate to have this beautiful home filled with a vast fountain of knowledge. She feels that the newspaper article regarding this cut left her with more questions than answers. She questions if there were any strings attached when the house was gifted to the City.

Scott Paoletto of 318 North 11th Street stated that people who are making meth are not only endangering themselves and those they sell and distribute to, they are also

endangering emergency response personnel and the community. Other citizens deserve to not have to worry about whether their neighbor is cooking meth or not. He asked if a City Ordinance could be enacted that would force people out of the City after they are found guilty of such offenses. We need to find a way to get these people out of Olean. This is not just a problem in Olean, but we need to try to get a grip on it before it gets worse.

Kevin Bartholomew of 737 Bishop Street stated that what Mr. Paoletto said is a sad reality. He also stated that now that the Bartlett House is taken care of for the next year, the City should look into a foundation to run the house. Anyone who wants to contribute could, and it could alleviate a lot of stress that the City has regarding funding the House. His concern is that we can't keep kicking the can down the road, because we will eventually end up in an alley and won't be able to move any further.

WHEREAS, the City of Olean Common Council approved a Bond Resolution on October 9, 2012 for the Wastewater Treatment Plant Upgrades Project, which was amended and restated on January 14, 2014 and again on June 23, 2015; and

WHEREAS, various projects including, but not limited to, piping replacements and concrete work, have been found upon further inspection and the City is desirous to complete additional work prior to the end of the Project; and

WHEREAS, no additional funding from the City is required for the project at this time, only consent to use contingency built into the original project funding;

BE IT RESOLVED, that the Common Council authorizes the use of up to \$255,000 of project contingency funds for the Wastewater Treatment Plant Upgrades Project for costs associated with engineering amendments and additional projects at the plant.

RESOLVED, if additional funding is necessary for said project, either from project contingency or other sources, O'Brien and Gere, the consultants hired for the project will be required to approach the Council for additional discussion.
