**TO AMEND THE WATER RATES PURSUANT TO SECTION 27-22 OF THE CITY OF OLEAN CODE OF
ORDINANCES**

WHEREAS, the Common Council will adopt the 2025-2026 budget reflecting amendments in the water rates; and

WHEREAS, a public hearing was held on Tuesday, April 8, 2025 in the Council Chambers of the Olean Municipal Building at 6:05 p.m. pursuant to Section 27-22(1) of the City of Olean Code of Ordinances; and

WHEREAS, water services provided by the City of Olean shall from time to time in each case be established by the Common Council pursuant to Chapter 27, Article II, Division 1, Section 27-22;
