TOWN OF BAILEYS HARBOR ORDINANCE NO. 1-03 Parking Ordinance

WHEREAS, it is in the public interest and welfare of the Town of Baileys Harbor to establish regulations for parking vehicles on the roadways in the Town of Baileys Harbor;

NOW, THEREFORE, the Town Board of Supervisors of the Town of Baileys Harbor, Door County, Wisconsin, does ordain as follows:

Section 1 - Authority

This ordinance is adopted pursuant to the authority granted in Wis. Stats. §60.22 and Wis. Stats. §349.13.

Section 2 - Purpose

This ordinance is created by the Town Board of the Town of Baileys Harbor with the intention of preventing parking on designated areas of Town Roads in the Town of Baileys Harbor to benefit the safety and security of the citizens of Baileys Harbor and others in the immediate area.

Section 3 - No Parking

No person may park a motor vehicle in any of the following locations in the Town of Baileys Harbor:

- A. Bluff Road from Guy Street west .10 mile, both sides of road
- B. West Cana Island Road commencing .60 miles south of East Bues Point Road to Cana Cove Road intersection, south side of road
- C. Cana Cove Road from West Cana Island to end, both sides of road
- D. West Bues Point Road commencing .30 miles south of East Cana Island Road for .10 mile, west side of road
- E. Kangaroo Beach Road from West Kangaroo Lake Road east to dead end, south side of road
- F. Ridges Road commencing from Lakeview Road for .10 mile east, south side of road, then 1.3 miles both sides of road
- G. Ward Street from Bluff Road south .20 mile, west side of road

- H. Park Road, on both sides of the road from its intersection with Hwy. 57 to its intersection with Hwy. F
- No parking in front of all entry/exit doors at the Baileys Harbor Fire Station, 2404 Park Road
- J. In any area of the Town of Baileys Harbor where a no parking sign has been installed upon the direction of the Town Administrator, Town Chairman, or Town Board of Supervisors

Section 4 – Penalties

Any person violating this ordinance shall be subject to a penalty of not less than \$25 nor more than \$100 for each offense.

Section 5 – Effective Date

This ordinance shall be effective on the day after its publication.
