Resolution #2024-06

**A Resolution Increasing the Rates for Wastewater System Use Effective January 1, 2025 and Thereafter Unless and Until
Subsequently Revised or Changed.**

WHEREAS, Section 15.01 of the Baileys Harbor Sewer Use and Sewer Service Ordinance requires that the Town review, at least every two years, the wastewater contribution of its sewer users, the operation and maintenance expenses of the wastewater collection and treatment facilities, and the sewer service charge system, and

WHEREAS, The Town Board has deemed it necessary to increase the rates to cover operating, repair and depreciation costs, and

WHEREAS, it is the intention of the Town Board to adjust Sanitary Wastewater Fixed Charge (Commercial) fee to \$81.00/EHU/Quarter, Sanitary Wastewater Fixed Charge (Residential) fee to \$140.00/Quarter, Sanitary Wastewater Rate (Commercial) fee to \$12.00/1,000 Gallons, Holding Tank Treatment Charge fee to \$20.00/1,000 Gallons. Septic Tank Treatment Charge fee to \$166.00/1,000 Gallons, Out of Town Septic Tank fee to \$180.00/1,000 Gallons, Out of Town Holding Tank to \$20.00/1,000 Gallons, In Town Grease Treatment to \$295.00/1,000 Gallons, Out of Town Grease Treatment to \$295.00/1,000 Gallons, Industrial Strength Waste to \$195.00/1,000 Gallons, EHU Sewer to \$6,500.00, and EHU Septic/Holding Tank to \$3,000.00.
