Recycle Center Updates

We continue to encourage all residents to recycle, as through our program with Brown County, we receive, currently, \$69/ton for our single stream recyclables! This offsets our costs by about ½-3/4 currently, that we pay to Brown County Port & Resource Recovery.

Please be mindful of proper items to recycle. If in doubt, contact the Brown County Port and Resource at Browncountyrecycling.org with questions.



Tax season is upon us so your property tax bills will be mailed by Brown County early in December. All tax bills must be paid either in person or by mail to Brown County Treasurer, 305 East Walnut St, Room 106 of the Northern Building, Green Bay WI 54301

Town of Humboldt's current tax rate will remain @ \$1.50/\$1,000 assessed value of your property for this tax season.

On your tax bills you will see a breakdown of the money received and what entities receive your taxes. School districts, County, and State all receive part of your tax monies paid. Also included on the bill are special assessments for the Town: 1. \$100 is assessed on all parcels with a fire number for capital expenditures, like the fire department or road signs; 2. \$50 is the charge for each household to utilize the recycling drop off center; 3. POWTS is a charge from Brown County to maintain your septic systems; 4. Brown County Drainage district #4 is a charge to maintain this district. 5. Special charges from the Scott Municipal Utility for sewer and storm water in the Village of New Franken.

New Franken Fire and Rescue Updates!

NWTC has agreed to offer a class for First Responders at the Morrison Fire Department this Spring! The class is tentatively scheduled to start February 1st, and end on April 7th. It will run Tuesdays and Thursdays from 6pm-10pm. County Rescue will cover the cost of the class and equipment to respond once you are licensed. DOG LICENSE

The annual dog tags are in for 2022 and can be purchased at any time.

ALL DOGS MUST BE LICENSED BY APRIL 1: ALL DOGS MUST HAVE A LICENSE AND BE CONFINED TO THE OWNER PROPERTY. Owners of dogs found harassing pedestrians; livestock, etc. will be fined. All livestock must be confined to owner's property.

LICENSE RATES ARE FOR EACH DOG:

Male \$8.50 Neutered Male \$3.50

Female \$8.50 Spayed Female \$3.50

ANYONE THAT HAS 4 OR MORE DOGS ARE REQUIRED TO PURCHASE A KENNEL LICENSE OR MULTIPLE DOG LICENSE. Multiple Dog License (Up to 12) \$36.50

Owners must present their RABIES VACCINATION CERTIFICATE that their dog is vaccinated against rabies by a veterinarian before the dog can be licensed. I also need the Pet Owners phone number for Dog license report sent to the Brown County Clerks Office. THIS RULE WILL BE STRICTLY FOLLOWED!!!!!
