day, seven days per week, from the time the Ballot Drop Boxes are placed into operation until after

the November 5, 2024 Election; and 2) that the video recordings of each said Ballot Drop Box be

retained until after January 15, 2025; and

BE IT FINALLY RESOLVED, that a copy of this Resolution shall be sent via email to

the Municipal Clerk, and to the Chief Elected Municipal Official, of each Brown County

municipality.
