RESOLUTION NO. 2026-02

A RESOLUTION DESIGNATING THE OFFICIAL WEBSITE AND VILLAGE HALL AS THE OFFICIAL POSTING LOCATIONS FOR ALL LEGAL NOTICES AND REPEALING PRIOR RESOLUTIONS DESIGNATING THREE PHYSICAL POSTING LOCATIONS

WHEREAS, the Village of Kekoskee is required by Wisconsin Statutes, including but not limited to Chapter 985 and related provisions governing the publication and posting of legal notices, to designate one or more locations for the posting of legal notices, agendas, and other official documents when posting is used in lieu of or in addition to newspaper publication;

WHEREAS, Wisconsin Statutes § 985.02(2)(a) provides that when a municipality elects to post legal notices, the notice must be posted in at least three public places likely to give notice to persons affected, OR must be posted in at least one public place likely to give notice to persons affected and placed electronically on an Internet site maintained by the municipality;

WHEREAS, the Village Board previously designated three physical posting locations (the Village Flower Shoppe at 16 County Road Y N, the Kekoskee/Hall at W3275 County Road TW, and the Kekoskee/Refuse and Recycling Site at N7856 County Road V), which designation is no longer the preferred or most effective method of providing notice to the public;

WHEREAS, the Village maintains an official website at Kekoskee.gov that is readily accessible to the public, and the Village Hall located at W3275 County Road TW, Mayville, WI 53050 serves as a central and convenient public location for the physical posting of notices;

WHEREAS, the Village Board has determined that designating the official Village website and the Village Hall as the official posting locations will better serve the public, improve accessibility and transparency, and fully comply with the requirements of Wisconsin law;

NOW, THEREFORE, BE IT RESOLVED by the Village Board of the Village of Kekoskee, County of Dodge, State of Wisconsin, as follows:

Section 1. The official Internet website of the Village of Kekoskee, currently located at Kekoskee.gov (and any successor official website address designated by the Village), and the Village Hall located at W3275 County Road TW, Mayville, Wisconsin 53050, are hereby designated as the official posting locations for all legal notices, meeting agendas, and other official notices required or permitted to be posted by the Village under Wisconsin Statutes Chapter 985 and any other applicable law.

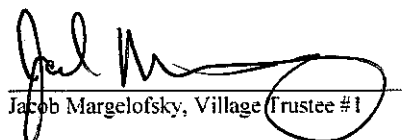
Section 2. Any and all prior resolutions, motions, or actions of the Village Board that designated three or more physical posting locations for legal notices (including the locations previously identified as the Village Flower Shoppe, the Kekoskee/Williamstown Hall, and the Kekoskee/Refuse and Recycling Site) are hereby repealed in their entirety and shall have no further force or effect.

Section 3. The Village Clerk is directed to post a copy of this Resolution at the newly designated official posting locations and to take all other actions necessary to implement the designations set forth herein.

Section 4. This Resolution shall take effect immediately upon its adoption and approval by the Village Board.
