

RESOLUTION NO. 3/2012-1  
AMENDMENT TO RESOLUTION NO. 6/2011-2  
CHANGE WARDS TO:

TOWN OF WESTFORD  
WARDS 1, 2, 3 & 4

WHEREAS, Resolution No. 6/2011-2 established Town of Westford Wards 1 & 2 and after the fact, the State of Wisconsin created Wards 1, 2, 3 & 4 for the Town of Westford, which requires the Town of Westford to re-establish Wards and amend Resolution No. 6/2011-2 and,

WHEREAS, municipalities are required to establish wards in accordance with Section 5.15 of the Wisconsin Statutes following the issuance of a federal decennial census; and,

WHEREAS, said decennial census has been issued; and the municipality has received a tentative supervisory district plan from Dodge County; and municipalities are required to make a good faith effort to accommodate the tentative plan submitted by the county.

NOW, THEREFORE, BE IT RESOLVED by the Town of Westford that there shall be 4 wards, the municipal boundaries of which are established as follows:

**Ward 1, containing a 2010 population of 906 and comprising part of tentative supervisory district number 4.**

A description of the boundaries of Ward 1 consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: those residents living east and north of County Road G. See attached map.

**Ward 2, containing a 2010 population of 322 and comprising part of tentative supervisory district number 4.**

A description of the boundaries of Ward 2 consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: those residents living south and west of County Road G. See attached map.

**Ward 3, containing a 2010 population of 12 and comprising part of tentative supervisory district number 4.**

A description of the boundaries of Ward 3 consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: those residents living in Millers Woods on Rose Circle in the Town of Westford. See attached map.

**Ward 4, containing a 2010 population of 0 and comprising part of tentative supervisory district number 4.**

A description of the boundaries of Ward 4 consistent with the conventions set forth in Section 4.003 of the Wisconsin Statutes, is set forth as follows: that portion of Beaver Dam Lake in the Town of Westford. See attached map.

**The polling place for Wards 1, 2, 3 and 4 is hereby designated as follows: Westford Town Hall, W11101 County Road G, Beaver Dam, WI 53916.**

BE IT FURTHER RESOLVED that there is attached to and made a part of this resolution a map of the Town of Westford which illustrates the revised boundaries of the above listed wards.

BE IT FINALLY RESOLVED That there is also attached to and made a part of this resolution a list of the block numbers used by the U.S. Census Bureau that are wholly or partly contained within each ward, with any block numbers partly contained within a ward identified.
